Dear Sir,

This is to inform you that I Kunal Bansal (s/o Kishan Bansal, resident of Vasundhara Apartment, near Kapil Center, 2nd mile) owner of Reebok showroom situated at Sevoke Road, near Payal Cinema would like to register a complaint of theft in my showroom. When my staff opened the showroom in morning at around 10:15 am there was no electricity in the showroom and when he tried to check the connection he found that the main cable, change over switch, fuse box was missing/stolen. The generator was also broken and the battery kept inside the generator was also found missing. On checking the cctv we found out that there was a group of 3-4 people including male and female around who at around 4:30 am climbed inside the premises to steal the said equipments. The total loss is estimated around more than Rs.50000/-

Under the aforesaid circumstances I therefore request you to investigate the matter, book the culprits under the appropriate provisions of criminal law and help us to recover our stolen goods.
