In producing herewith four (04) arrested accused persons namely (i) Mohan Roy (28) s/o Lt. Tapen Roy of Khudirampally near Sonai Furniture, PO- Sevoke Road, PS-Bhaktinagar, dist- Jalpaiguri [not verified] (ii) Dipankar Roy (31) s/o Lt. Tulin Roy of Chota Fapri near Sani Mandir, PO- Sevoke Road, PS- Bhaktinagar, dist- Jalpaiguri [not verified] (iii) Sahadeb Roy (31) s/o Bimal Singh Roy of Bholanathpara near Flour Mill, PO- Goghomali, PS- Bhaktinagar, dist- Jalpaiguri [not verified] and (iv) Bishal Roy (22) s/o Domashu Roy of Khai Khai Bazaar, Ektiashal ,PO- Sevoke Road, PS- Bhaktinagar, dist- Jalpaiguri [not verified] arrested u/s- 35 BNSS along with following seized articles viz:

(1) One iron made Hasua measuring 2 feet (approx.) including wooden butt found from the possession of Mohan Roy which was kept in his right hand.

(2) One iron made rod measuring 2 feet (approx.) found from the possession of Sahadeb Roy which was kept concealed on his back side.

(3) A hacksaw blade measuring 1 foot (approx.) found from the possession of Deepankar Roy which was kept in his left hand.

(4) A black colour torch light (chargeable) having style as AK-5952 found from the possession of Bishal Roy which was in his right hand.

I, SI Agen Lepcha, S/O- Lt. Dup Tshering Lepcha of Ashighar OP under Bhaktinagar Police Station, Siliguri Police Commissionerate do hereby lodge this complaint against the abovenoted accused persons namely (i) Mohan Roy (ii) Dipankar Roy (iii) Sahadeb Roy (iv) Bishal Roy and others to the effect that today on 06/11/2024 at 00:20 hrs received source information that 14/15 youths have assembled at a vacant land near Kankata More under Bhaktinagar PS with a view to commit docoity in a house at Jaleswari area. Accordingly, the fact was diarized in GD vide Ashighar OP GDE No- 132 dated 06/11/2024. Subsequently, after sharing the information with my superior and as per his direction, I along with ASI-Sumith Baran Nath, ASI- Dinesh Ch. Roy, C/1547- Prabir Das, C/970 Bikash Roy, C/1686 Krishna Kanta Tiwary, C/-1575 Malay Debnath, CV/1034 Manojit Barman, CV/ 603 Arun Roy and CV/1016 Amrit Roy left for the place to verify the veracity of source information. At about 00:35 hrs after reaching near Kankata More under PS- Bhaktinagar, I met my source and being pointed by the source we started walking towards Kankata More. At around 00:45 hours, we reached Kankata More and began to cordon off the suspected individuals identified by our source. We had a strong reason to believe that they were preparing to commit a cognizable offence and were about to leave the area. However, upon noticing the police approaching, they attempted to flee. After a hot chase, we successfully apprehended four accused individuals along with the seized articles mentioned above. Unfortunately, a number of others managed to escape from the spot taking advantage of darkness.

During interrogation, the apprehended individuals admitted that they had gathered there with the intent to commit dacoity at a house in the Jaleswari area under the Bhaktinagar police station.

I thereafter, seized the above-noted weapons under the proper seizure list and videography duly signed by the witnesses and acknowledged by the accused persons. The whole seizure was made in between 00:58 hrs to 01:07 hrs. Following that, I arrested the above-noted accused persons u/s 35 BNSS under a proper memo of arrests duly signed by the accused persons and also supplied a copy of the memo of arrest to them.

Subsequently, I brought the arrested accused persons along with seized articles to Bhaktinagar Police Station for further investigation. During the course of interrogation, it could be revealed from the arrested accused persons that they were gathered there to

commit dacoity in a house in Jaleswari area.

Hence, under the above noted facts and circumstances a specific case may kindly be started under proper section of Law against the above noted accused persons viz. (i) Mohan Roy (28) s/o Lt. Tapen Roy of Khudirampally near Sonai Furniture, PO- Sevoke Road, PS- Bhaktinagar, dist- Jalpaiguri (ii) Dipankar Roy (31) s/o Lt. Tulin Roy of Chota Fapri near Sani Mandir, PO- Sevoke Road, PS- Bhaktinagar, dist- Jalpaiguri (iii) Sahadeb Roy (31) s/o Bimal Singh Roy of Bholanathpara near Flour Mill, PO-Goghomali, PS- Bhaktinagar, dist- Jalpaiguri and (iv) Bishal Roy (22) s/o Domashu Roy of Khai Khai Bazaar, Ektiashal, PO- Sevoke Road, PS- Bhaktinagar, dist- Jalpaiguri, and others and arrange for its investigation.
