In producing herewith 02 (two) arrested accused persons namely 1) Md. Ansar Ali (42 yrs),S/O-Azgar Ali of 12/4 Tapsia 2nd lane, Tiljala, South 24 Pargana (A/P- Mayfaire-1, Room No- 306, PS-Matigara, Dist- Darjeeling) and 2) Sourav Sahu, S/O- Sanjay Sahu of Champasari Anchal near Young star club, PS- Pradhannagar, Dist- Darjeeling (A/P- Tumbajote Gas godown, PS- Matigara, Dist- Darjeeling) along with the following seized articles as per Seizure List:

i] Fifty Nine (59) Pieces of CPU.

I beg to report that today on 05.11.2024 at about 18:35 Hrs, during my evening patrolling van duty received a reliable secret source information that some persons are running an illegal call centre at Webel IT Park, Siliguri Phase II, 1st Floor, Paribahannagar under Matigara PS,SPC in the Office named MODULE-3 without any valid documents for their wrongful gain. Accordingly I, informed the matter to Inspector In charge of Matigara Police Station and as per his direction I along with officers and forces namely ASI Naresh Thapa, C/811 Ruben Ekka, C/225 Arun Kumar Roy, C/974 Mintu Sen, C/162 Mahendra Nath Roy, LC/1251 Yankila Bhutia, LC/1359 Bhawani Barman, LC/1324 Lalita Singha, left to work out the information vide Matigara PS GDE Entry no.210, Dated: 05.11.2024.

At around 18:55 Hrs I along with officers and forces reached the 1st Floor, at Webel IT Park, Phase II and being shown by the source, we held raid at a room styled as MODULE-2D inside which three LAB styled as LAB-I, LAB-II and LAB-III were found and also found inside those LABs some of the staff were working there with computer sets. We introduce ourselves as Police team and on being asked them about the owner of the Office for producing the valid license and other relevant documents for running the said offices. Accordingly the person namely Ansar Ali came forward before the Police Team and introduced himself as the supervisor of the Office. I also found one laptop styled as LENOVO and one mobile styled One Plus from the possession of Ansar Ali.

Inspector-In-Charge

On being asked the staffs they stated that they were hired two days ago and since then they were being trained to make calls to international customers through internet voice protocol. The staffs are also stated that the person namely Ansar Ali is giving them training how make survey and make false international call and how to cheated the customers. I asked them about the owner of the Office but was not able to give any details since they were recently hired at the said office. There was strong reason to believe that the owner of the said company was running the said office illegally for his wrongful gain. Hence I seized the above noted articles with proper seizure list.

On being asked the person namely Ansar Ali, he stated that he had been working as the supervisor of the Office for his owner namely Rajib Saikiya. He also stated that he used to provide fake service of Internet upgrade/Speed Test service to the international customers by making international calls through internet voice protocol to cheat the hard earned money of the customers. And also trained staffs how to cheat customers by making false international calls.

On further enquiry to the other staffs of the said office stated that they were hired by the owner of the company and being trained by Ansar Ali since last two or three days for making international calls through internet voice protocol. They were supplied scripts and guided by the above noted accused persons for making international calls.

On demand of Licence and other valid documents to run the Call Centre the above noted accused person could not produce any DOT Licence or any other documents authorising him to run the said offices wherein he had international clients.

During enquiry the above noted person confessed that he was working in his office as supervisor/human resource under the guidance of his Boss named Rajib Saikiya. During enquiry all the staffs of the above noted Offices stated that they were being trained for the last three days for making calls through internet voice protocol.

There was a strong reason to believe that the above noted accused person under the guidance of his owner was running the call centre illegally at the above noted office for their wrongful gain. The other staffs who were working as trainees were refrain from their work and they also came to know that the owner of the above noted office was running call centre illegally for cheating the international customers. Accordingly, I seized the above noted articles in presence of independent witness and arrested the person namely Ansar Ali after informing the ground of arrest. The seizure was made on 05.11.2024 in between 19.10 Hrs to 19.30 Hrs. All the seized articles were kept at the room named MODULE-2D which was sealed situated at the 1st floor of Webell IT Park, Phase-II under Matigara PS jurisdiction. The whole process of seizure was made under videography.

Further interrogated the arrested accused person namely Ansar Ali stated that Sourav Sahu who was previously present as a seizure witness supervise him. He worked in this office as a partner of Rajib Sakiya. On being Interrogated Sourav Sahu admitted that he along with Rajib Sakiya running the office for their wrongful gain. Accordingly I also arrested Sourav Sahu, S/O- Sanjay sahu of Champasari Anchal near Young star club, PS- Pradhannagar, Dist- Darjeeling (A/P-Tumbajote Gas godown, PS- Matigara, Dist- Darjeeling)

PS- Pradhaunagar, Dist- Darjeeling (A/P- Tumbajote Gas godown, PS- Matigara, Dist- Darjeeling) Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused persons namely 1) Md. Ansar Ali (42 yrs),S/O- Azgar Ali of 12/4 Tapsia 2nd lane, Tiljala, South 24 Pargana (A/P- Mayfaire-1, Room No-306, PS- Matigara, Dist- Darjeeling), 2) Sourav Sahu, S/O- Sanjay Sahu of Champasari Anchal near Young star club, and others and arrange for its investigation.
