Sir,

In producing herewith three accused persons namely (i) Pulak Roy, aged 25 years, s/o- Late Shanti Roy, resident of West Aptair, PS- Hili, Dist- Dakshin Dinajpur, (ii) Soumitra Paul, aged 42 years, s/o- Ashutosh Paul, resident of Dhulatur, PO- Atrai, PS- Balurghat, Dist- Dakshin Dinajpur and (iii) Pritam Sarkar, aged 34 years, s/o- Late Gour Sarkar, resident of West Aptair, PS- Hili, Dist- Dakshin Dinajpur (not verified) under custody along with the following seized articles under proper seizure list:

1. One silver colour 7.65 mm Pistol measuring approx 6 inches on body length & 4 inches wooden butt along with one active hammer, one trigger, one empty magazine with safety pin. The wooden butt is encrypted with "Star" mark; (recovered & seized from the possession (front waist under cream colour T-shirt) of Pulak Roy) and marked as Exhibit-A.
  2. One silver colour 7.65 mm Pistol, made in USA, measuring approx 6 inches on body length & 4 inches butt along with one active hammer, one trigger, one empty magazine with safety pin. The butt is made of yellow colour metal; (recovered & seized from the possession (front waist under light green colour T-shirt) of Soumitra Paul) and marked as Exhibit-A.
  3. Thirty (30) nos. of 7.65 mm K.F. live ammunitions recovered & seized inside a yellow colour polythin carry bag from the right pocket of Pritam Sarkar; marked as exhibit-C.
  4. One blue colour Infinix android mobile phone from the possession of Pritam Sarkar.
  5. One blue colour Redmi android mobile phone from the possession of Soumitra Paul.
  6. Three (03) nos. ash colour Cellelor keypad mobile phones from the possession of Pulak Roy.

I, SI Debabrata Kundu of Bagdogra PS, SPC do hereby lodge this written complaint against the above noted arrested three accused persons to the effect that today on 06.11.2024 at 15:30 hrs received secret source information that three persons carrying & possessing firearms & ammunitions are coming from Dakshin Dinajpur on a bus to sell firearms to their designed customer near Bagdogra Airport approach more under Bagdogra PS for their wrongful gain. Accordingly, I appraised the matter to O/C Bagdogra PS and diarized the matter in GD vide GDE No. 236 dated 06.11.2024. Then as per direction of O/C Bagdogra PS, I formed a team with SI Samik Paul, ASI Amit Lama, ASI Munna Ahmed, C/1509 Sourav Roy Sarkar, VP/02 Pradip Roy & VP/01 Ansalam Kujur, CV/375 Jogesh Barman, CV/386 Kishor Ranjan Howladar & CV/389 Janak Singh and left for Bagdogra Airport approach more under Bagdogra PS vide MCC No. 290/24 dated 06.11.2024 to work out the secret source information. This refers to Bagdogra PS GDE No. 237 dated 06.11.2024. Our source accompanied us. At around 15:55 hrs we reached at Bagdogra Airport approach more under Bagdogra PS and ambushed there. After a while, at around 16:20 hrs our source identified the suspects. Accordingly, as per identification and indication by source, we managed to apprehend three suspects on the service road (towards Bagdogra side) of NH-31 in front of Jaipal Singh Munda Community Hall near Bagdogra Airport approach more under PS- Bagdogra in presence of independent witnesses namely Ved Prakash, aged 47 years, s/o- Late Bijay Kr. Mehta, resident of Bhuttabari, PS- Bagdogra, Dist- Darjeeling & Krishna Paul, aged 23 years, s/o- Late Basudeb Paul, resident of Bhujiapani Bazar, PS- Bagdogra, Dist- Darjeeling. We disclosed the identity of our raiding team and the input we had to them and interrogated them. On interrogation, they revealed their identity as noted above. Subsequently, we searched their persons in presence of independent witnesses. On search, one silver colour 7.65 mm Pistol was recovered from the possession (front waist under cream colour T-shirt) of suspect Pulak Roy, another silver colour 7.65mm Pistol (made in

USA) was recovered from the possession (front waist under light green colour T-shirt) of the suspect Soumitra Paul and thirty (30) nos. of 7.65 mm K.F. live ammunitions were recovered inside a yellow colour polythin carry bag from the right pocket of the suspect Pritam Sarkar. Besides, five mobile phones were recovered from their joint possession. On prolong interrogation they disclosed that they had been carrying & possessing two illegal firearms with live ammunitions and they had come from Patiram in Dakshin Dinajpur district in order to sell the firearms to their designed customers for their wrongful gain. On demand they failed to produce any valid license/document for possessing & carrying firearms & live ammunitions. Subsequently, I seized two recovered firearms, thirty live ammunitions & five mobile phones from their joint possession under proper seizure list and labeled the same in presence of independent witnesses. At last, I arrested the above mentioned three accused persons for possessing and carrying illegal firearms with live ammunitions after telling them the ground of arrest to prevent the accused persons from committing any further offence, to prevent them to cause disappearance of evidence as well as for proper investigation of the case and issued memo of arrest in this regard. The process of search, seizure & arrest was done in between 16:27 hrs & 17:15 hrs on 06.11.2024. The entire process of search, seizure & arrest is done through audio-video electronic means using mobile phone and then the same audio-video record is converted to a pen drive using computer system.

Therefore, I request you to initiate a specific case under proper sections of law against three accused persons namely (i) Pulak Roy, aged 25 years, s/o- Late Shanti Roy, resident of West Aptair, PS- Hili, Dist- Dakshin Dinajpur, (ii) Soumitra Paul, aged 42 years, s/o- Ashutosh Paul, resident of Dhulatur, PO- Atrai, PS- Balurghat, Dist- Dakshin Dinajpur and (iii) Pritam Sarkar, aged 34 years, s/o- Late Gour Sarkar, resident of West Aptair, PS- Hili, Dist- Dakshin Dinajpur (not verified) and arrange for its investigation.
