Bhaktinagar, District- Jalpaiguri, PIN-734001 in the state of West Bengal, would like to lodge this Written Complaint before your good office to the effect that I am a driver and I am engaged with the Balaji Logistics.

Sir, it is to be mentioned here that in regular course of my duty, I visit Reliance D.C. for loading vehicle and I supply the goods at different pick up center/Reliance Mart in Siliguri at it's near by areas.

Sir, on 02.11.2024, my boss called me over phone and per his instruction I went to the Reliance D.C. situated at Near Gora More, P.O. Sahudangi, P.S. New Jalpaiguri for the purpose of loading the Vehicle at about 03:00 P.M in the morning and I parked my vehicle in the D.C. premises and kept waiting for loading the vehicle and in course of loading I kept waiting for a very long period and during that period I asked one of the staff namely Tapas Roy of D.C. many times to inform me as to when they are going to load my vehicle but they did not paid any heed to my request and at about 11:00 P.M. he left the Seat and his duty time was over and another person namely Rana joined the duty and when I asked the staff of the D.C. as why he is doing delay in loading the vehicle at this one of the staff namely Ashutosh Halder, S/o unknown having Contact number 97496-02778 along with another staff namely Krishna, S/o unknown having Contact No. 85090-01862 started to abuse me with filthy

language and Ashutosh Called two unknown persons from outside the D.C. and started to assault me with fists and blows and as I was alone they all beaten me very badly and the above mentioned Ashutosh pull out an Iron punch from his pocket and continuously assaulted in my head and as such my head had a very grievous injury and I fell down on the floor and they were continuously threatening me that they will kill me as they are the locals but somehow I managed to rescue myself from their clutches and ran outside the D.C. where another driver rescued me and took me to Maharaja Nursing Home and a was treated in the Maharaja Nursing Home and I had multiple stitches on my head and I had excessive bleeding from my head and due to such bleeding I was not able to see properly.

Sir, it is to be mentioned here that the entire incident is recorded in the C.C.T.V. of the D.C. Warehouse and as I was bed ridden due to the severe and grievous head injury the delay in lodging the FIR has been caused.

I, therefore, fervently requesting you to look into the matter properly and please take necessary steps against the above mentioned persons and also take proper steps as per law and obliged thereby.
