Sir,

I Mrinal kanti mondal S/O. late sibendra nath mondal resident of Dabra, Trimohini, P.O. Trimohini, P.S Hili, Dakshin Dinajpur.

Would like to inform you that a case began with an FIR lodged by SMT. PINKI SINGH, she is a tenant for six years at the residence of a person namely Tapash Ghosh in Pradhan Nagar, Darjeeling. SMT. PINKI SINGH reported that on **27/09/2024**, Mridul Kanti Mondal @ Kajal, a driver at Annapurna Bakery and also a tenant at the residence of Tapash Ghosh entered her kitchen while she was cooking, grabbed her suggesting that her husband could not give her a child and to provide him with a chance. SMT. PINKI SINGH managed to escape by kicking him, after which he fled. And being distressed by the incident, she initially refrained from telling her husband to avoid family issues. However, noticing her depression, her husband, Niraj Singh, repeatedly kept asking her, and on 05/10/2024, she disclosed the incident to him. Niraj Singh then confronted Annapurna Bakery's owner, leading to a confrontation between them.

Later that day i.e. on 05/10/2024, another FIR (Pradhan Nagar P.S. Case No. 651/24) was lodged against Niraj Singh by Kalyan Kr. Saha and Tapash Ghosh stating that Niraj came to shop on 05/10/2024 at around 7:20 p.m. in intoxicated condition and began shouting and using offensive language without reason. When Kalyan Kr. Saha and Tapash Ghosh questioned him he reportedly pushed, kicked, and slapped them, then demanded a donation of ₹50,000 for "Durga Puja" and claiming he has strong political connections. When they refused, Niraj began damaging the shop with a bamboo stick and threw stones, threatening to close the shop and harm

them if the payment was not made and when nearby locals and shopkeepers intervened Niraj fled.

That Mridul Kanti Mondal @ Kajal was arrested and produced before A.C.J.M. Court and was kept in custody for about 24 days. That later on 30/10/2024 he was released on bail and returned home on 01/11/2024 for the Siliguri Special Correctional Home.

That ever since he returned from the Siliguri Special Correctional Home, he has been facing health issues and was very depressed as he was involved in this case with false intention. That after the bail, he heard taunts and heart breaking comments on his character from the society people and not being able to handle the situation wisely, he committed suicide 06/11/2024, at near National public school, Pokajote, Champasari, P.S. Pradhan Nagar, Siliguri.

Sir, firstly My Brother Mridul Kanti Mondal @ Kajal was a very simple person dedicated with his work and he was brought into this case falsely by the said **SMT. PINKI SINGH** and his husband **Niraj Singh** because of her, Mridul Kanti Mondal @ Kajal committed suicide Yesterday.

With utmost respect, I urge you to kindly take necessary legal actions against the said PINKI SINGH and Niraj Singh as soon as possible as per convenience.
