Respected Sir,


I, the undersigned, would like to draw your kind attention towards the fact that today my son, namely 1. Parijit Ghosh, 2. Parikhit Ghosh, along with Monish Ghosh, surrendered before the Ld. Additional Chief Judicial Magistrate at Siliguri after they got Anticipatory bail from the Hon'ble High Court at Calcutta, Circuit Bench at Jalpaiguri in the case being C.R.M (A) No. 654 of 2024. That after surrender when the counsel on behalf of my sons and Monish Ghosh went to furnish the bail bonds for further procedure, the bail bonds were snatched away from the hands of the counsel appearing on behalf of my sons and Monish Ghosh by the below mentioned Advocates and others. Thereafter we were brutally assaulted, by the below mentioned advocates to which we sustained serious injuries. The entire incident was captured in the CCTV present at the court premises. I further request you collect the CCTV footage from the court inspector as soon as possible.

On 27.08.2024 when I went to the Siliguri Police Station to lodge complaint against the accused persons my complaint was not received by the concerned police station.

I therefore request you to direct the Inspector-in-charge Siliguri Police Station to action against these accused persons as per provision of law.


