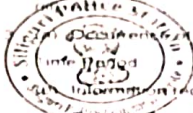

I, Mrs. Mina Kumari Gupta (67), the undersigned complainant, wish to inform you that on the date of 04/11/2024 at approximately 9:30 pm, my son-in-law, namely Ramesh Kumar Gupta, S/O Keshav Prasad Gupta, and his wife Mrs. Sneha Gupta, residing near Ramdeo Khatol, Ganga Nagar, Ward no.5 SMC, P.O and P.S Siliguri, entered into my house and started abusing me and my husband namely, Sri Rameshwar Gupta(75), S/o Lt. Jadunandan Gupta, and when we protested, he started beating us with bamboo and wooden stick and threatened us for live consequences in future. He often used to beat and threaten us for the last 2 years.

Sir, the above noted alleged person is very violent and dangerous in nature and he may again assault me and my family physically.

So, please take necessary action against them.
