Mondal along with my brother namely Gautam
Kumar Mondal (15) S/o Sri Manoj Mondal, both are
resident of Santoshi Nagar (Near Ram Janki Mandir)
reached at Hemanto Basu colony, Ward No. 4, to
bring our Toto as usual at that time the above
noted alleged persons namely (1) Ganesh Kamti,
(2) Suresh Kamti, both sons of Sri Nareesh Kamti,
(3) Nareesh Kamti S/o Jammun Kamti (4) Titendra
Das S/o Sugurath Das (5) Sanjay Singh S/o Bhushan
Singh & (6) Md. Beelam, all one of Hemanto Basu
BNS Colony, Ward No. 4, P.S-Siliguri, who were gambling
there, started demanding money from them
and when they denied, they took out Belts, knuckle
punch & knives and attacked on my father & my brother
and injured them severely and stolen away a
Silver chain (14 Bhai) from the neck of my father.
My said father & brother immediately shifted to
Siliguri Distt. Hospital & treated themselves there.
