Jannu Kanti all are of Kachra Maata, Near Shiv Shakti Mandir, Hemanto Busu Colony, Ward No-4 SMC, P.O & P.S-Siliguri, Distt-Darjeeling (5) Ranju Singh s/o Bhudhan Singh of Kachra Maata, Near Shiv Shakti Mandir, Hemanto Busu Colony, Ward No-4 SMC, P.O & P.S-Siliguri, & (6) Md. Bechan s/o Not known of opp. Madurshy Hemanto Busu Colony, Ward No.4 SMC, P.O & P.S-Siliguri, Distt-Darjeeling (7) Smt.
