I am Sanjib Paul, S/o Late Bijendra N.
Paul, a PGT physics teacher of a school in Siliguri,
rental resident of Roy Bari, YMA Ground, Babu-
Para humbly requesting and applying for a
First Report Information Report FIR, against
a crime committed with me by 4-6 people or
goons who were drunken and motivated to
do this crime at Tikia Para vegetable market.

It was 10.40 pm, yesterday night, 4/11/24,
went for buying vegetable and when I was
returning from the vegetable shop of Raju Sarker
(phone no. 77183 81777) four (4) goons attacked me
from back side, grabbed and twisted my
left arm causing blood stained injury on it.
they started to scratching my i-phone 15
plus-black, and were hitting severely
on head and throat, causing severe
injury in my vocal cord, wind pipe
as they were strangulated me.

they caused severe injury in my
vocal cord-spine & in it surrounding, damaged
my i-phone 15 plus (new-I on 11th, 80,000/-)

blood clotting on left arm. and wanted
to cause damage of bike - Paul. Somehow
I managed to save myself from these (4-5)
miscreants whose identity can be done by me.

I am attaching my medical reports,
X-ray, ENT & orthopedic treatment's
documents & for identity of miscreants
four I am attaching their vehicle
numbers, & pictures.

My humble request to you to nab
miscreants for sake of justice and for
army safety.
