Sub: Application to register complaint regarding theft in place of business

I, Jhutan Das (Aadhar Number - 2228 7015 4184), son of Nityahari Das, would like to inform you that I, (Jhutan Das) am the proprietor of wholesale trading business Binny Collection (GST No. 19BFXPD5943J1ZQ). I would like to inform you that multiple goods including cash was subjected to theft from my place of business located at 125/1/123, Chanda Park, Near Dayamoi Kalibari, Mahananda Para, Siliguri, District: Darjeeling, West Bengal - 734005.

This incident came to my notice when I came to open my shop in the evening of 5th November, 2024 and discovered that the lock of the main gate is broken and one of the drawers where I keep my cash is also broken. Cash approximately Rs. 58,300.00 was taken away along with goods (Bra - 12 pieces - Value Rs. 3,420.00, T-shirt - 7 pcs - Rs. 3,493.00, Track pant - 4 pieces - Rs. 3,396.00). The matter was promptly reported to the nearest shops, offices, landlord and locals in the area.

I therefore request you to kindly register a complaint in this regard and do the needful in this regard.
