In producing herewith 04 (Four) arrested accused persons namely (1)Badal Paswan @ Chota Badal-19 yrs S/O- Lt. Indrajit Paswanof Bagrakote, W/No- 20,PS- Siliguri, Dist. Darjeeling(2) Sanjib Das @Doga- 21yrs S/O-Sambhu Das of Chittaranjan Colony,Bagrakote, W/No- 20, PS- Siliguri, Dist. Darjeeling(3) SonababuSahani-21yrs S/O- Mohan Sahani of Durga Nagar Colony near Kumartully, W/No- 04,PS- Siliguri, Dist. Darjeeling(4) Bigen Tamang-24 yrs S/O- Shering Tamang of Jhankar more, W/no- 07, PS- Siliguri, Dist. Darjeelingarrested on 07.11.24 u/s- 35(1) of BNSS along with following seized articles viz: -

- One knife with a wooden handle measuring about 10inches (Approx) from the possession of accused Badal Paswan which was kept in his right hand.
- One knife with a wooden handle measuring about 10inches (Approx) from the possession of accused Sanjib Das @Doga which was kept in his right hand.
- One iron rod measuring about 25inches (Approx) from the possession of accused SonababuSahani which was kept in his right hand.
- One nylon rope measuring about 30 feet (Approx) from the possession of accused Bigen Tamangwhich was kept in his right hand.

I, PSI Koushik Raha S/O-Jitendra Raha of Siliguri Police station under Siliguri Police Commissionerate do hereby lodge this complaint against the above-noted accused persons and six/sevenothers to the effect that, on 07.11.24 at 01.05hrs received a source's information that 10/11persons have assembled at South Bharat Nagar near Jorapani bridge under Siliguri PS for preparing to commit dacoity in a house at Siliguri PS area. The fact was diarized in G.D vide Siliguri PS GDE No.327 Dated 07.11.24 Subsequently after sharing the information with I/C PS andas per his direction, at 01.15hrs myself along with SI Uday Chakraborty,ASI Debasish Das, ASI Rabin Lama, C/160 Soumen Sarkaralong with ASI Bishnu Das (K-21 Van Officer) and C/384 Biswanath Barman along with kits left for the place to work out the information. This refers to Siliguri PS GDE No-328 dated 07.11.24.

We reached PO at 01.30hrs on 07.11.24 and waiting there, subsequently cordoned off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offense and were about to move from that Place. Sensing the police had cordoned off, they tried to flee away but on hot chase, we managed to apprehend the above-noted 04 (Four) accused persons along with seized articles as mentioned above. However, the other 6/7 persons managed to flee away from the spot taking advantage of the darkness. On interrogation, the accused persons admitted that they had assembled there to commit dacoity in a house at Siliguri PS area.

I thereafter, seized the above-noted weapons under the proper seizure list duly signed by the Witnesses and acknowledged by the accused persons. (The whole seizure was made on 07.11.24 between 01.35hrs to 02.05hrs) Thereafter, I arrested the above-noted accused persons u/s 35 (1) of BNSS under proper memo of

arrests duly signed by the accused persons and also supplied a copy of arrest memo to them. The process of search & seizure has been audio & video graphed at the PO.

I accordingly, brought the arrested accused persons along with seized articles to Siliguri Police Station for further investigation. During interrogation, they stated that they were gathered there to commit Dacoity in a house at Siliguri PS area.

Hence, I pray before your good self that, a specific case may kindly be started under proper section of Law against the above-noted accused persons viz. (1) Badal Paswan @ Chota Badal-19 yrs S/O- Lt. Indrajit Paswan of Bagrakote, W/No- 20, PS- Siliguri, Dist. Darjeeling(2) Sanjib Das @Doga- 21yrs S/O- Sambhu Das of Chittaranjan Colony, Bagrakote, W/No- 20, PS- Siliguri, Dist. Darjeeling(3) Sonababu Sahani-21yrs S/O- Mohan Sahani of Durga Nagar Colony near Kumartully, W/No- 04,PS- Siliguri, Dist. Darjeeling (4) Bigen Tamang-24 yrs S/o- Shering Tamang of Jhankar more, W/no- 07, PS- Siliguri, Dist. Darjeelingand six/sevenothers and arrange for its investigation.
