Respected Sir,

With due respect, I beg to state that Four (4 Nos.) CCTV camera were installed one year ago in our building. Yesterday i.e on 02/10/2024 (Wednesday) madrasah was closed on account of Gandhi Jayanti and Mahalaya. Today i.e on 03/10/2024(Thursday) after reaching madrasah, it is found that two cameras installed in the corridor of the 1st floor, are not working, showed on the monitor in office room. Then we started searching the cause for nonfunctioning of the cameras and found that one of the CCTV camera is stolen and other camera is still in its place but not working as the cables are cut. After going through the footage, it is found that all the cameras were functioning properly till 01/10/2024 (Tuesday) till 6:15 pm.

I would like to also inform you that there are two computer labs in the madrasah building and many more valuable items and official documents are also available and these are at now risk as the miscreants may damage madrasah property in future.

Under this circumstances, I would like to request you to investigate the matter to secure madrasah property and take necessary action please.
