I, Sri Sanjan Chick Baraik, son of late Subash Baraik, resident of Ten Line, Gulma T.E. P.O. Gulma, P.S. Pradhan Nagar, Dist Darjeeling beg to report you that today on 08/11/2024 at about 02 P.m. my daughter namely Miss Subela Chick Baraik, aged 16 years had left home by cycle uninformed, but by evening when she did not come back home, then I started searching her but went in vain. I contacted all our relatives and well-wishers over mobile phone, but no one could say her whereabouts. We tried to call on her phone, many times, some times it rings, but sometimes it is off. She talks a little and have limited friends. She never live in any other place except own house. So I am in apprehension whether my daughter is trapped by any human trafficking gang. I, therefore, humbly request you to lodge this diary in your P.S. and do the needful in this regard, so that my daughter may be rescued.
