Respected Sir,

I, UTTAM KUNDU, Son of Late Gopal Kundu, Proprietor of Kundu Carrying Corporation, having its office at Fulbari Parking Ground, Fulbari, Police Station: New Jalpaiguri, District: Jalpaiguri, in the State of West Bengal, PIN – 734015, beg to state as follows:

- That my above noted firm namely Kundu Carrying Corporation deals with the booking of goods vehicle from different transport companies, loading and delivery of goods from various clients and the said deals are on commission basis.
- 2) That on 22/10/2024 Baramati Agro Limited (Poultry Feed Factory), situated at Ambari, Police Station – Bhorer Alo, District – Jalpaiguri, West Bengal engaged my above noted firm to load its Poultry Feeds weighing 25 Metric Tons and deliver the same to their godown situated at Jorhat, Assam.
- That for the above reasons I hired a Truck bearing No. WB 59A 5935 from D.K. Roadways, having its office at Jhankar More, Jyoti Nagar Colony, Police Station Siliguri, District Darjeeling, West Bengal, Represented by Proprietor Tarun Das and I also paid Rs. 30,000/- (Rupees Thirty Thousand) only as advance out of total fare of Rs. 52,500/- (Rupees Fifty Two Thousand Five Hundred) only.
- 4) That as per the note vides No. 319 dated 22/10/2024 issued by said D.K. Roadways in favour of my firm, the name of the owner of said vehicle no. WB 59A 5935 is Shakilur Rahaman of Bardhaman and thereafter said vehicle no. WB 59A 5935 loaded the poultry feeds weighing about 25 Metric Tons worth of about Rs. 15,00,000/- (Rupees Fifteen Lacs) only at Ambari Factory, Police Station Bhorer Alo, District Jalpaiguri and went away to deliver the same to the godown of said Baramati Agro Limited situated at Jorhat, Assam.
- 5) That problem started after lapse of 3 (Three) days, when I came to know that the said goods (poultry feeds) were not delivered to the godown of said Baramati Agro Limited situated at Jorhat, Assam.
- 6) That thereafter I inquired the matter from various sources and came to know that the above noted vehicle no. WB 59A 5935 which I hired from D.K. Roadways was running with fake number plate and documents and also came to know the original owner of the said number plate bearing no. WB 59A 5935 is another person having Mobile No. 96350 – 46338 and also the Driving License of the driver of the said fake vehicle is also forged.
- 7) That after such incident I enquired the matter with the proprietor of D.K. Roadways namely Tarun Das and this time he provided the name of the owner of the vehicle no. WB 59A 5935 as UDDIPTA MITRA, 2A/10, Vivekananda Park, Wear Arrah More, Durgapur, Bidhan Naga, West Bengal 713212.
