Respected Sir/Madam,

Rekha Sharma wife of Ajay kumas sharma of pradhan para (word 42)
I am writing with deep concern about the ongoing threats, abusive behavior, and intimidation my family has been enduring from Sanjay Sharma, his son Roshan Sharma, and his wife Ranjana Sharma.

Despite previous interventions from your department, these individuals continue to make our lives unsafe, and we fear for our lives and well-being.

Here are specific instances of their recent actions, which clearly demonstrate a disregard for the law and intent to cause harm:

- 1. Physical Vandalism: On Sunday, 10/11/2024, when I left the house, Sanjay Sharma deliberately broke the water tap on the terrace, resulting in an empty water tank. This act of vandalism caused us further inconvenience and showed his intent to provoke us.
- 2. Verbal Threats and Harassment: After breaking the tap, both Sanjay and Roshan Sharma began hurling abuses and issuing death threats toward Ramdeni Sharma and our family, using explicit language intended to instill fear.
- 3. Threats Against My Daughters: I am deeply concerned about my daughters' safety, as I fear that Sanjay Sharma and Roshan Sharma are planning to harm them. Their behavior has been increasingly hostile, and the nature of their threats is extremely disturbing.
- 4. Defiance and Intimidation Post-Police Intervention: Even after your visit yesterday, Roshan Sharma brazenly continued his threats, saying, "Now that the police have gone, what will you do?" This shows a complete disregard for police intervention and continues to make us feel unsafe.
- 5. Constant Harassment by Whistling: Roshan Sharma is frequently whistling in the stairway as a form of harassment, a tactic clearly meant to intimidate and provoke us. This repeated action has added to our distress and fear within our own home.
- 6. Threat of False FIR by Ranjana Sharma: Additionally, Ranjana Sharma has threatened to file a false FIR against Ramdeni Sharma's son and other family members, stating that she would destroy our careers and have us jailed. This has been mentioned in previous complaints, yet the threats continue.

Despite our appeals for help, Sanjay, Roshan, and Ranjana Sharma have shown no signs of stopping their harassment and threats, which have left us in constant fear for our safety. I have two daughters and I feel

Sanjay Sharma and his son Roshan Sharma are planning to harm them. This toxic environment and the escalation in threats have made it unbearable for my family to feel safe in our own home.

Request for Immediate Action: We urgently request that you take strict action against Sanjay, Roshan, and Ranjana Sharma to prevent any harm to our family. We are fearful that these individuals may act on their threats, and we seek your protection to ensure the safety of our loved ones.

Thank you for your urgent attention to this matter.
