With due respect I Laila Begum w/o Anawarul Rahaman residing at Champasari More , word no 46, Anandamoy Colony , PO and P.S Pradhanagar, Darjeeling like to draw your kind attention on the following effect that I resides in the above mentioned address since my marriage and in this said land the above mentioned accused persons are also resides and from the beginning they created nuisance and conspiracy against me and my sons and my husband. It is mentioned here that the accused no 1 wahida Parveen few years back resides in Delhi but came back five months ago and from then she create problems against my family and without any reason she always using filthy languages upon us.

Today at about 9.30 p.m. when elder son Rafiqul Rahaman went to his job the accused no 1. Wahida Rahaman without any reason started using filthy languages and at that time I came out from kitchen and defend her and asked her why she using filthy languages, she started beat me here and there and she also called the above named accused persons and they also beat me and kick me with bamboo stick and as a result I sustain grievous injury in my head and stomach and when my son try to rescue me, they also beat me son and also threatened us to kill. After that me and my son some how fled away and went to Siliguri District Hospital and there my treatment is going on.

Therefore I request you please look into this matter as soon as possible and take proper legal action against it as I am very much afraid if we go back to home they beat me or try to kill us again.
