I was returning home with my daughter after buying gold jewelry from Ranidanga Nabawadip Jeweler's. After getting down from Toto two strangers came on a bike, pushed me and ran away with the bag. I could see nothing of them because of the darkness of the night.

INR 15000/- cash, Gold ornaments with original bill voucher value of Rs. 23000/- approx. and two debit card etc. in that bag.

So, I request you to kindly register an F I R against this incident and take necessary action to recover my bag.
