I, Sumanta Barman, the above noted complainant
beg to inform you that on St. 13.11.2024 at about
06:10 pm, I reached in front of Mrs Anjali Jewellers
Ashrampara, ward no. 14 smc, P.S - Siliguri, being
receiving a whatsapp call from my friend namely
Rohit Roy, noted above and when I reached there
driving my motor cycle and they restrained me
and, S/o Mussum @ Masum, noted above rided over
my motor cycle ^{as pillion rider} being Regd. No WB-74-BJ-6236
and took me at Durgam ~~by force~~ and there I found
all of them where they restrained me for a while
and thereafter they took me in the basement/parking
place of under Haveli Restaurant, H.C. Road and
there they beaten me with fist & blades and
demanded Rs. 0500000 (Rs. Five lacs) only from
me and when I refused to pay such a huge
amount then above noted alleged persons took
cut, Rs 3500/- (Three thousand five
hundreds) approx from my pocket and left
the place leaving me & my motor cycle.

Sir, the above noted alleged persons are very
disputant & dangerous in nature and they have
threatened me for dire consequences.
So please take necessary action against them
