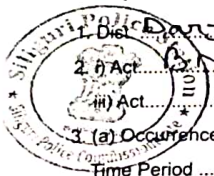

I Kundan Paswan, son of Dilip Paswan, resident of Sagina Mahato Road, Saraban Nagar, Ward No. 18, P.S- Siliguri, Dist:- Darjeeling begs to state as follows:-

- ① That in the above mentioned address I along with my parents and one elder brother and one youngest sister stays in that house.
- ② That on 11/11/2024 my younger sister namely Rina Paswan went to college para to see the Puja but she did not return home untill 10:30 P.M. When ~~she~~ she did not return home we started searching for my sister namely Rina Paswan aged about 22 years. but when we did not find any clue about her at around 11:00 P.M. a person namely Titendar called me over the mobile phone from 620234108 and said me that they have taken my sister to there house and if.

we want to meet my sister then we have to go to his house situated at Chakaur, Nathani Road, P.S. Nathani, Dist:- Baguisarai, Bihar.

③ That on 12/11/24 at about 4:30 am we left for the above mentioned address but after we reached there they did not let us meet with my sister and instead threatened us of dire consequence if we do not give Rs. 5,00,000/- in return to take our sister or else ~~we~~ ① Dinesh Paswan ② Munna ③ Rekha Devi, w/o Dinesh Paswan ④ Mahinder Kumar ⑤ Jitender Kumar ⑥ Rajan Kumar, will sell my sister and will force her into prostitution.

④ That on 13/11/24 again they called me and said my sister is senseless and needs urgent medical attention and for the same they need money or else she will die.

⑤ That on 12/11/24 when we went to meet her they did not allow us to meet her and instead demanded huge sum of money.

⑥ That I could not lodge the P.I.R in due time as we were in deep fear and in tension as they all are very dangerous in nature and anything might happen to my sister if not rescued from them urgently.

⑦ That if my sister is not rescued as soon as possible then they will sell my sister and force into prostitution.

I therefore request you to kindly take necessary legal action at the earliest for the ends of justice.
