I, Nikhil Thakur, S/o Sri Manoj Thakur, age 22 yrs. an employee of Sri Sanjay Tibrewal, resident of 195, Agrasen Road, Siliguri:-734005, would like to inform you that today (14.11.2024) at 1.30p.m. a thief entered the residence of my employer by breaking the lock open of the main gate. While undertaking a stealing spree of wires of A.C., Geysers and other electrical appliances he caused damage by breaking the electrical gadgets and destroying other items. I caught hold of him and overpowering the man handed over to you. In the process of scuffle the man being raged, tried to attack me by an iron rod but failed in his mission.
