Subject: Complaint against Sri. Atul Agarwal S/O Sri. Devi Dayal Agarwala, resident of Seth Srilal Market, Near Ritik Plaza, lane behind Platinum Building Siliguri – 734001 for causing physical and mental torture and mis-appropriation of my movable and immovable properties.

Sir,

I Smt. Ambika Agarwal W/O Sri. Atul Agarwal aged about 51 years, by occupation housewife bring to your kind notice:

1. That I was given in marriage to Sri. Atul Agarwal in the year 1998 and out of the said wedlock, I gave birth to two children namely Ayushmaan Agarwal (25 years) and Vedant Agarwal (18 years), since after marriage we lived together as husband and wife at Seth Srilal Market, Siliguri together with my father-in-law namely Sri. Devi Dayal Agarwala and my mother-in-law namely Smt. Bimla Devi Agarwal.
2. Soon after my marriage I was subjected to physical and mental torture by my husband Sri. Atul Agarwal. I was physically assaulted on various occasions and given mental trauma but I bore all the torture silently due to thinking about my children. Now both my children have grown up and objected when my husband again assaulted me, my father-in-law is physically an incapable person and he is helpless in the matter but my mother-in-law Smt. Bimla Devi Agarwal all along supported and instigated my husband whenever he committed torture upon me and my children. Lastly, at the instigation of my mother-in-law my husband drove me out from my home in the month of March 2024 and I went at my father's place at Kolkata along with my younger son in a single cloth. Three years before the incident my elder son was driven out by my husband from our house and he started living with my in-laws at their Iskon Mandir Road house (Shree Radha Apartment, Block C, 1st Floor) in Siliguri.
3. Few days ago around 1st week of October I got a reliable information about my husband's extra marital relation with a woman named Rimpa Agarwal W/O Mukesh Agarwal residing at 2nd mile, Sevoke Road, Siliguri. After getting the said information my elder son Ayushmaan Agarwal went to my husband's house situated at Seth Srilal Market, Siliguri, where my son found the lady Rimpa Agarwal coming out from the said house. My son entered the house and confronted my husband then he became furious and couldn't explain the reason for solo visit of the said lady. On 19/10/2024, my elder son and his wife (married on 04/07/2024) were also driven out by my mother-in-law and they got forced to stay at my father's place presently. Now myself along with my 2 children and 1 daughter-in-law are forced to live at my father's place and we are living at the mercy of my father.
4. My husband has kept all our jewellery (gold, silver, diamond), papers of landed properties, documents viz. Passport, Aadhar, Pan Card, IT file, bank accounts and other documents with himself and we are

spending our days in extreme distress. I'm not getting any financial help from my husband and I have been forced to put my signature on various legal documents in past, contents of which are not know to me. My mother-in-law and my husband has hatched up a conspiracy to usurp our legal rights including all our belongings and properties too. The constant torture in the hands of my husband has made me a patient of depression for which since last 12 years I am on medication.

Hence, I request you register an FIR against the said Sri Atul Agarwal and investigate the matter and help me to recover all my movable and immoveable stree dhan properties and belongings with appropriate remedies etc.
