Sabila Badyakar do here by stating that I doing a small business running a pan shop in my own shop measuring 100sq ft. near my locality, I am physically handicap due to this I am unable to do any hardwork for living my life, at the time my childhood my grand father was run this shop after death of my grand father I take the shop in my possession. I have my trade license issued by Siliguri Municipal corporation as well as Holding tax also. On dated-10/11/2024 around 11 AM those ladies are forcefully came near my shop keeping some iron rod and other instruments and started vandalizing my shop, seeing all the incident I reached in my shop and try to stop them, then they suddenly told me that that is their shop they try to forcefully enter in my shop when I try to stop them they started slap me, beat me with wooden stick, after hearing their shout my sister-in law came in my shop and when she try to understand all the incident then they suddenly started abusing her in filthy languages they also assaulting my sister-in law namely-Gulshan Beagum, due to my physical problem I could not save my sister-in law. They all are threatened us they forcefully capture my shop in the midnight, after this incident my family members take me to the district hospital for treatment, at the same day they further started threatened me that they implicate false police case upon me because they are lady. The next day local councilor call a meeting for settle this matter but they don't want to settle this matter, that the reason I lodge this F.I.R on today now I am very scared because they can harm me physically and illegally occupy my shop with their power.

So I request before you to kindly investigate this matter fair and proper way and take strict action against all them from your ends
