Sir, it is pertinent to say that by my marriage was solemnized nearly 05 (five) years back with said Ratan Roy noted above under Hindu rites & rituals and since after my marriage my said husband and his above noted family members became dependant on my income because my said husband is a habitual drinker & never earned any money. Due to their atrocities, I left my matrimonial house nearly 03 (three) years back with my minor son and started staying at my parental house, and do not want to go to my matrimonial house.

So, please take necessary action against my said husband & his above noted relatives for subjecting me physical & mental cruelty.
