Subject: Written Complaint regarding Trespass, Threats, and Intimidation by Mr.  
Bibhuti Das.

Respected Sir,

I, the undersigned, hereby lodge this written complaint regarding a disturbing incident that occurred at my Chamber at Bidhan Road, Siliguri on the evening of 06.11.2024 at around 8:00 p.m.

One Mr. Bibhuti Das, son of Late Manindra Kumar Das Chowdhury, resident of Deshpriya Sarani, Pradhan Nagar, Siliguri, District - Darjeeling, PIN - 734003, having contact number 9832026409, whom I represented as an advocate in Case No. TS. (Ev.) 62/2020 in the Court of the Ld. Civil Judge, Jr. Div. at Siliguri, unlawfully trespassed into my chamber at Bidhan Road, P.O. & P.S. Siliguri, Dist. - Darjeeling, accompanied by several unidentified individuals and demanded a refund of Rs. 17,000/- which he had paid as my legal fees, expressing dissatisfaction with my services.

It is pertinent to note that, as per his instructions, I prepared drafts of various necessary petitions, including a plaint and a petition under Section 51A(4) of the West Bengal Land Reforms Act, 1955 after the said Case No. TS (EV)62/20 was withdrawn. In the course of finalising the draft, it was detected that the said Bibhuti Das provided misinformation to the Ld Civil Judge, Junior Division at Siliguri by stating in his plaint that he was his father's only child and only legal heir and so inherited all his father's property and so I requested him to provide certain documents, including evidence related to his succession rights to the property in question, upon which the suit was to be based. However, Mr. Das requested time to gather these documents, and I awaited his submission to proceed with the case filing. Prior to the Puja festival, he informed me that his elder sister opposed filing the suit and requested the return of his documents, which I duly handed over to him.

His actions were intended to undermine my reputation within the community and damage the professional integrity I have built over 36 years..

This behaviour has deeply disturbed me and has impacted my personal sense of security and professional stature. The aggressive and intimidating nature of his actions has aggravated the offence, which I fear may recur without proper legal intervention.

Therefore, I request you to kindly investigate the matter and take appropriate legal action to ensure my safety, preserve my professional integrity, and deter such behaviour in the future.
