In producing herewith four (04) accused persons namely (i)Bishal Routh (28yrs) S/O Lt. Lakhan Routh of Coolipara, ward No. 01, PS Pradhannagar, Darjeeling (ii) Rahul Chhetri(24Yrs) S/O Lt. Manoj Chhetri of Pipenala, Salugara, BSF Road, PS Bhaktinagar, Jalpaiguri (iii) Akhilesh Kumar (27yrs) S/O Shri Bhagawan Kumar of Dagapur, Panchanadi, Pradhannagar PS Darjeeling and (iv) Prince Kumar(23yrs) S/O Lt. Ganesh Sha of Sanjay Math, Panchanai Colony, ward No. 01, Pradhannagar PS Darjeeling under arrest and the following articles under seizure viz i) One sharp cutting weapon locally called knife measuring approx 9 inches including wooden handle. ii) One iron made "Shabol", locally called "BAKI", measuring approx 22 inches. iii) One iron Hacksaw measuring 19 inches including its wooden handle. iv) One iron Hammer measuring approx 15 inches including its iron handle. v) One iron plus measuring approx 08 inches, and vi) One white colour hand bag printed as "Gold Mohor". I, SI Rajiv Subba of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted 04 (four) arrested accused persons and others 05/06 unknown miscreants who involve in this crime to the effect that on 16.11.2024 at 01.20 hrs I received a specific source information that about 10/11 miscreants equipped deadly weapons, and house breaking articles assembled at Himachal Colony near in abundant place near Railway Quarter under PS- Pradhan Nagar, Dist.-Darjeeling and are taking preparation for committing Dacoity at Himachal Colony and its surrounding areas.

Accordingly, I informed the matter to you and diarized the fact in General diary vide Pradhan Nagar PS GDE No 824 dated 16.11.24 and as per your kind order and direction myself along with ASI Biplab Kr. Das, ASI Prabal Sarkar, C/1169 Prasenjit Barman, C/1119 Tamnoy Roy and C/1416 Dilip Barman all of Pradhan Nagar PS left for Himachal Colony under Pradhan Nagar PS, Dist.- Darjeeling by Govt. vehicle with investigation kits to verify the veracity of the information without any search warrant or authorization for search which could not be possible to obtain from a competent authority for sudden development of a sensitive information and not to afford them opportunity for concealment of evidence or facility for their escape. I also informed one videographer namely Somnath Chatterjee, S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No 22, PS- Siliguri, Dist.- Darjeeling over mobile phone and requested him to come to Himachal Colony with his camera for the purpose of videography if required. On the way, I briefed all the Police personnel sharing the information in hand and also informed RT K-30, van officer ASI Amar Raj Subba of Pradhan Nagar PS and requested him to come to Himachal Colony to accompany with us. At around 01.45 hrs we arrived at Himachal Colony and after a while RT Van Officer ASI Amar Raj Subba and his force came to Himachal Colony and accompany with us. I briefed him and his team properly sharing the information in hand. At around 01.55 hrs on 16.11.24 the above mention videographer called me over mobile phone that he came at Himachal Colony. I requested him to come to Himachal Colony. Then, I contacted with my source and from a considerable distance he pointed the place where the miscreants were assembled. Then, I requested two independent witnesses namely (i) Ram Narayan Mondal (40 yrs) S/o Lt. Dhiren Mondal of Pati Colony 01 No. Road near Gate Bazar, P.S. Pradhan Nagar, Dist. Darjeeling and (ii) Shibu Roy (32 yrs) S/o Lt. Tarani Kanta Roy of Haripur near Railway station, NJP P.S., Dist. Jalpaiguri and I shared the information with them and requested them to remain present and act as witness if any search and seizure would be made, upon which they agreed.

Thereafter, we proceeded towards Himachal Colony near in abundant place near Railway Quarter under Pradhan Nagar P.S. and cordoned the place with due care and cautioned and from a considerable distance we noticed that some persons were assembled inside the said abandon place and they were whispering in a low voice. On seeing police personnel approaching towards them they tried to flee away from the broken wall of the quarter but on hot chase we managed to apprehended above noted 04 (four) accused persons while 05/06 others unknown miscreants managed to fled away from the broken gate of the said spot. Thereafter, we disclosed our identities as Police personnel (as we were in civil dress for our convenience). On interrogation, they disclosed their identities as noted above. On search recovered the above noted weapon of offence from their joint possession.

On further interrogation, they furnished incoherent statements and failed to give any satisfactory reply for their presence with deadly weapons in such deaf hour of night. Finally they disclosed that they along with 05/06 of their associates assembled there and were making preparation for committing Dacoity at Himachal Colony and its surrounding areas. Accordingly, I seized the above mentioned weapons of offence from their joint possessions under proper seizure list in between 02.15 hrs to 02.40 hrs on 16.11.24 in presence of independent witnesses and duly signed by the witnesses and acknowledged by the accused persons and subsequently arrested them under proper memo of arrest and observing all the formalities of arrest. They are informed over the ground of arrest. The whole process of search and seizure were made under the coverage of video graph by the videographer namely Somnath Chatterjee, S/o Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No. 22, PS- Siliguri, Dist. Darjeeling as per norms of BNSS and brought all the four (04) arrested accused persons along with seized articles to Pradhan Nagar Police Station for further investigation. From the above noted facts and seizure of incriminating articles there is strong reason to believe that all the above noted four (04) accused persons along with others who fled away gathered there equipped with deadly weapons, and house breaking articles at such dead hour of night and taking preparation to commit Dacoity in a nearby affluent area at Himachal Colony and its surrounding areas.

Under the above circumstances, I pray before you that a specific case under proper section of law against may kindly be started against the above noted four (04) arrested accused persons namely (i)Bishal Routh (28yrs) S/O Lt. Lakhan Routh of Coolipara, ward No. 01, PS Pradhannagar, Darjeeling (ii) Rahul Chhetri(24Yrs) S/O Lt. Manoj Chhetri of Pipenala, Salugara, BSF Road, PS Bhaktinagar, Jalpaiguri (iii) Akhilesh Kumar (27yrs) S/O Shri Bhagawan Kumar of Dagapur, Panchanadi, Pradhannagar PS Darjeeling and (iv) Prince Kumar(23yrs) S/O Lt. Ganesh Sha of Sanjay Math, Panchanai Colony, ward No. 01, Pradhannagar PS Darjeeling and others 05/06 unknown miscreants and arrange for its investigation.
