I, SI Madan Rishi of NJP PS do hereby lodge this written complaint against Medical driver namely Gurpal Singh (male/ 65 years) S/O Kundan Singh of Jyoti Nagar Ward No 41 PS.Bhaktinagar Dist. Jalpaiguri to the effect that today on 11.11.2024 I alongwith force were performing evening mobile van duty vide NJP PS GDE No. 610 dt. 11.11.24 and at 15.35 hrs during my mobile van duty received a telephonic information from Duty Officer ,NJP Ps that an accident was taken place at Fulbari Bye Pass more, near Traffic point & he requested me to look into the matter immediately which noted in GD vide NJP PS GDE No. 614 dt. 11.11.24. As soon as myself & forces rushed to the spot and found three vehicles including one Bus having RC No WB 76A/3803 of Narayana School are being rampantly standing there for which causing disturbance of passerby. Myself and forces intervened and made traffic flow normal and locally inquire into the matter & it could be learnt that the driver of School Bus was playing his vehicle ,going towards Tinbatti more & rashly & negligently dashed 02 four vehicles having Registration No. WB74AA/3779 and WB 74 BN /8400 on backside which were standing at Traffic Ponit, Fulbari. As a result of which the boarding students of the bus became puzzled and scared and two four wheelers were partially damaged. The local agitated public gheroad the driver of School bus alleging that he was driving the School bus consuming liquor with dangerously in that busy road. However I intercepted the driver of the Bus, on asked he disclosed his name and address mentioned above and the students of Bus have been handed over safely to teachers of that School. Thereafter the intercepted driver of bus was produced at nearby Maharaja Agrasen Hospital, Fulbari for his examination where the alleged intercepted driver was declared him Alcoholic intoxicated. However I arrested the driver of the offending vehicle U/S 35 BNSS as being intoxicated the driver was playing the student bus with rashly & negligently with knowledge for his this negligent act could be occurred death of person of that place. Accordingly I seized the offending Bus and also the two victim vehicles as per proper seizure list.

Under the circumstances I am requesting you a specific case may kindly be initiated against the alleged bus driver namely Gurpal Singh (male/ 65 years) S/O Kundan Singh of Jyoti Nagar Ward No 41 PS.Bhaktinagar Dist. Jalpaiguri under proper section of law.
