Sub: Complaint against counterfeit Apple Inc. accessories

Sir,

1. This complaint is being filed on behalf of Apple Inc. ("Complainant Company"). The authorized representative of the Complainant Company is Mohd. Tauqeer s/o Sh. Kalay Khan, R/o K-12 J J Colony, Wazirpur, P/s Bharat Nagar, District - North West Delhi who is authorized by way of the attached Power of Attorney.

2. Apple Inc. is the industry leader in manufacturing of electronic goods under the brand names Apple, iPhone, iPad, Airpod, etc. The Complainant Company exercises strict quality control over the production of its products including the use of the intellectual property in the writing manner of Apple logo, the word mark "iPhone", etc.

3. It has come to the knowledge of the Complainant Company that **M/s Agarwal Enterprises, Rishi Aurobindo Road, Hakimpara, Siliguri** within your jurisdiction is engaged in illegal, unauthorized and unlawful sale of identical and deceptive products of Apple Inc. along with substantial and identical reproduction of the artistic work of the company's product packaging, thereby amounting to infringement of the copyright vested in the Complainant Company's artistic work under the Copyright Act, 1957.

4. In light of the above stated facts, you are requested to take legal action of my complaint. You are also requested to investigate into the matter including arrest of the accused persons and seizure of the counterfeit products which amounts to infringement of copyright.
