With due respect I, **SMT. ASHA SARKAR**, Wife of SriBiplab Barman, resident of Baikuntha Pally, Ward No. 41(S.M.C.),P.O. Sevoke Road, P.S. Bhaktinagar, District- Jalpaiguri in the state of West Bengal would like to lodge this Written Complaint to the effect that one Sri Ratan Das(having contact number 9832554579 and 9733536691), Son of Unknown who is my neighbor and residing at the same address,is known to me since last 6 years as he also resides in the same locality.

Sir, it is to be mentioned here that my husband resides in Kamakhyaguri, Alipurduar District for his business and after this Durga Poojathe above mentioned Ratan Das started to follow and stalk me in every now and then and somehow he had managed my contact number and he started to call on my phone on odd times and always expressed about his wife and daughter as how they tortures him and the above mentioned person always requested me to help him out from such situation and in the last week the above mentioned person expressed his ill motive towards me and when I raised my objection upon his such proposal he threatened me with dire consequences.

Sir, it is to be mentioned here that on last day i.e. 14.11.2024 at about 07:00 A.M. the daughter of Ratan Das Namely Miss Moni Das invited me to their house as she had asked for the help from me and without thinking anything I went to their house for helping them but after reaching their I noticed that the Wife of Ratan Das, Smt. Rina Das was ready and she in connivance with her daughter assaulted me with the wooden club and as a result I sustained severe injury and the local people gathered at the house they torn my nighty and pulled my hair.

Sir, it is to be mentioned here that after the meeting in the locality it was decided that no party shall file any complaint against each other and I acted accordingly.

Sir, it is to be mentioned here that today, i.e. <sup>15-11-24</sup> at about 06:00 P.M. the above mentioned Miss Moni Das and he mother Namely Smt. Rina Das forcefully entered into my house and they started to



assault me with fists and blows and Miss Moni Das attacked on my head with Rice utensil(Haari) on my head by which I sustained severe head injury and they also assaulted me with Iron Rod by which I have sustained severe cut mark on my body and they torn my wearing Apparels and during such assault the above mentioned persons taken away a sum of Rs. 4,500/- from my house and the above mentioned lady has threatened that she will falsely implicate my son in some false criminal cases and after such incident I took medical assistance from Siliguri District Hospital.

Sir, therefore kindly do the needful.
