Sir, In producing herewith one female accused person namely- Momina Khatoon (35 yrs) W/O Md Kalam of Tikiapara, Matangini -II, Ward No.28, PS- Siliguri, Dist- Darjeeling along with the following seized articles as per proper seizure list:

1. Twenty (20) sealed Bottles of Himalayan Gold country spirit 60 UP each bottle containing 600 ML having batch no. SS2HG058(2)Nov-24, amounting of Rs.160/- each,
2. 09(nine) sealed bottles of Kingfisher Imperial Strong Beer containing 650 ml each, amounting of Rs. 160/- each,

I, ASI Debasish Das of Siliguri PS, SPC lodged a written complainant against the above noted person to the effect that today i.e. on 17.11.24 at 15.05 hrs received a source information that one female person namely Momina Khatoon of Tikiapara under Siliguri PS was standing at Railway Colony Math under Siliguri PS with huge amount of liquor illegally for selling the same in her design customer for her wrongful gain. This refers to Siliguri PS GDE no- 903 dated 17.11.24. I informed to I/C Siliguri PS about the above mentioned information. As per order of I/C Siliguri PS, I along with ASI Subir Sen, ASI Rabin Lama, C/160 Soumen Sarkar, LC/1313 Mili Roy proceeded Railway Colony Math under Siliguri PS to work out the information vide Siliguri PS G.D.E No. 904 dated 17.11.24. At 15.25 hrs we reached at the spot, sometimes after being identified by the source our police party found that the above noted mentioned lady person was busy to sell liquor to her design customer. On seeing the police party all consumed persons managed to flew away but we managed to apprehend the above noted lady person. On being asked she disclosed her identity as noted above. On searched the above noted seized articles as per seizure was found from her possession. On further interrogation she failed to produce any valid documents in respect of above noted mentioned seized articles. On further interrogation she became nervous and admitted her guilt before us and stated that she sell the same to her design customers since long for her wrongful gain. In presence of witnesses namely 1.Mala Roy (60) W/O Late Sushanta Roy of Railway Colony Math, Tikiapara, Ward No. 28, PS- Siliguri, Dist- Darjeeling, 2. Sandhya Roy (56) W/O Sisir Roy of do and LC/1313 Mili Roy of Siliguri PS/SPC, I seized the above noted articles from the possession of above noted accused person after preparing proper seizure list and label and took signature of the accused person and witnesses duly signed by them. The seizure was made between 15.25 hrs to 15.55 hrs. I arrested the said persons u/s 35(1) of BNS with the help of Lady force after issuing a Memo of arrest appraising the ground of arrest in presence of witnesses and also maintaining her decency as she violated the norms of Bengal Excise Act. The whole seizure process was recorded under Audio and Videography.

I therefore request you a specific case may kindly be started against the accused person namely Momina Khatoon (35 yrs) W/O Md Kalam of Tikiapara, Matangini -II, Ward No.28, PS- Siliguri, Dist- Darjeeling under proper section of law.
