Sir,

I Shivji Prasad, the above noted complainant beg to inform you that, my son namely Suroosh Kumar Gupta (42), was taking teacher training at, Maulani P.S. - Mal, Distt - Jalpaiguri at G.N.R. High School under D.L.E.D. Circle and there he became friendly with said Ranjit Das and he was known to him as a normal friend, but recently after 06 (three) years, he managed my mobile number from some other source and in the month of September 2023, said Ranjit Das called me over my mobile phone and told me that he can recruit me as a primary teacher in one Govt. School.

on 02.10.2023, the said Ranjit Das came to my house at Nehru Road, Khalpara and induced me and said that, we have to pay Rs. 2,00,000/- (Two Lacs) to him for that. I trusted him and paid Rs. 1,00,000/- (One Lac) only and on 02.10.2023 at about 05:00 pm, at Naya Bazar, Khalpara and later on he gave me a fake appointment letter and shown me a fake website to ensure me that my son again paid the balance amount of Rs. 1,00,000/- (One Lac) only through R.T.C.S. at UCO Bank, Burdwan Road, Siliguri Branch, through my A/c No. 1706110038062 to the A/c of said Ranjit Das, bearing No. 30776421070 State Bank of India, Mal Bazar Branch.

But when my said son namely, Suroosh Kumar Gupta, went to Bharati Hundi Vidyalaya (Primary) at Ramkrishna Colony, Siliguri, on 16.10.23 as per appointment letter, I came to know that the said appointment letter is false, then I contacted said Ranjit Das, he told that he will return the whole amount, but even after lapse of more than one year, he did not return the amount, then I decided to lodge F.I.R. against him.

Sir, me & my said son trusted said Ranjit Das, but he cheated us after inducing us.

So, please take necessary action against said Ranjit Das, noted above.
