Sir,

With due respect, I am producing herewith one accused person namely Md Salim (27) S/o Nutfun Hoque @ Nutful of Doulatpur, PS Dalkhola, Dist. Uttar Dinajpur under arrest along with seized cattle and seized vehicle ;

1. Thirty eight (38) numbers of cattles (Cow) in different color and different size.
2. One Vehicle (Truck) having Registration No. WB-59-D- 0808 which used to carry the seized cattles SL.No. 1.
3. One Driving License having No. WB-59-20180045140 in the name of Md Salim S/o Nutfun Hoque of Soulatpur , Dalkhola, Karandighi, Uttar Dinajpur , issued by L.A. Uttar Dinajpur valid upto 05.12.2024.
4. One Android Mobile Phone , model – VIVO T2x5G, Sim No. 9679991586 from the possession of Md Salim I, ASI Uttam Kundu Of New Jalpaiguri PS under Siliguri Police Commissionerate do here by lodged a written complaint against the above noted accused pevrson (driver) to the effect that on 17.11.24 at 08-35 hrs received a secret source information that some vehicle are being loaded cows illegally coming towards Jalpaiguri side from Phansidewa side without any valid documents/papers and if immediate action is taken, it can be apprehend . Accordingly I shared the information to you and duty officer of PS. Thereafter as per your direction myself alongwith NVF-0202 Khokan Sarkar , HG-1125 Jiban Roy left for Fulbari to verify the veracity of information which diarised vide New Jalpaiguri PS GDE No. 935 dt. 17.11.24. At 09-15 hrs we reached at Fulbari More opposite Maharaja Hospital (Nursing Home) and Just after few minutes on the basis of secret information we intercepted the one vehicle and apprehended the driver of the said vehicle having No. WB-59-D- 0808. On checking the vehicle we found Thirty eight (38) numbers of Cattles (Cows) in different color and different size were loaded on the vehicle. On being asked the apprehended driver disclosed his name and address mentioned above and admitted him as driver of the said vehicle and also stated he was carrying the Cattles in his vehicle from Purnia , Bihar side towards Jalpaiguri for selling the same illegally. On asked, he failed to produce any License/ papers in support of carrying the said Cattles in that vehicle and also failed to produce any papers/documents in respect of the said Cattles. It is crystal clear and reason to believe that the above noted accused driver procured the said cattle by illegal means or by stolen means for dishonestly dispose the same to earn huge money illegally. On further checking it was found that there was no arrangement made for food and water for the said Cattles as per Govt. rules. Besides this there was no sufficient space for the Cattles in that vehicle. The apprehended accused driver of vehicle also failed to produce any papers/documents in support of the said vehicle. Accordingly I seized Thirty eight (38) numbers of Cows in different color and different size and (ii) One Vehicle (Truck) having Registration No. WB-59-D- 0808 which was used to carry the Cattles (iii) One Driving License having No. WB-59-20180045140 in the name of Md Salim S/o Nutfun Hoque of Soulatpur , Dalkhola, Karandighi, Uttar Dinajpur and (iv) One Android Mobile Phone , model – VIVO T2x5G, Sim No. 9679991586 as per proper seizure list duly sign by the witnesses and arrested the apprehended person u/s 35 BNSS. The seizure and arrest have been made in between 09-35 hrs to 10-55 hrs.

Under the above circumstances, I pray to you that a specific case may kindly be started against the above noted arrested driver namely Md Salim (27) S/o Nutfun Hoque @ Nutful of Doulatpur, PS Dalkhola, Dist. Uttar Dinajpur of the above noted seized vehicle having No. WB-59-D- 0808 to arrange for its investigation.
