Sir,

With due respect, I am producing herewith 02 (two) arrested accused persons namely [1] Sonam Tashi Tamang (25 yrs), S/O- Ashok Kr. Tamang of Below Ashangthang, Ward Saighari, PO+PS- Jorhung, Dist- Namchi, South Sikkim (not verified), [2] Harsh Kr. Tamang (22 yrs), S/O- Sukumar Tamang of Halimchawk, W/No- 19, PS- Sadar Kishanganj, Dist- Kishanganj, Bihar (not verified) under arrest. The ground of arrest duly been communicated with them and the following articles under seizure :-

- (i) 01 (One) iron made local one shutter fire arms having wooden butt and Marked as "Exhibit-" "A".
- (ii) One live ammunition (303) and marked as Exhibit-"B".

I, PSI Avijit Banik of Matigara PS, SPC do hereby lodge this written complaint against the above noted arrested accused persons. In this regard, I beg to report that on 18.11.2024 I received a secret reliable source information that two persons are staying at a abandoned room at Chandmoni near Chumta bridge under Matigara PS jurisdiction with fire arms and ammunition to deliver the same to their designated customer. Accordingly, I informed the matter to you and as per your direction, myself along with ASI Pema Dorjee Sherpa, C/523 Sanjit Kundu, C/868 Sujal Roy and C/219 Sanatan Chitrakar all are of Matigara PS, SPC left for Chandmoni near Chumta Bridge under Matigara PS to work out the information in hand by Govt. vehicle. We reached at the spot i.e. Chandmoni near Chumta Bridge at about 22:40 hrs and as indicated by the source we were able to apprehend two persons who were staying at the abandoned room at Chandmoni near Chuma Bridge. On being asked they disclosed their identity as noted above. As per source information, that they were possessed improvised fire arms and ammunition. Hence, immediately I searched the room and found [1] 01 (One) iron made local one shutter arms having wooden butt which is Marked as "Exhibit-" "A" and [2] One live ammunition (303) which is marked as Exhibit-"B". from the said room which were concealed under the mat where they were staying. They exclusively possessed fire arms and live ammunition illegally. On demand they failed to produce any document in support of the said fire arms and live ammunition which has been found from their possession. On further interrogation they stated that they came at Siliguri to deliver the same to their designated customer for their wrongful gain. Thus when their involvement in carrying and possessing illegal fire arms and live ammunition was established, I seized that fire arms and 01 (One) round of live ammunition under proper seizure list duly signed by them as well as by available witnesses. Accordingly, I, arrested the apprehended accused persons after issuing memo of arrest informing them about the ground of arrest. The whole processes of search, seizure, label and arrest was made in between 22:50 hrs to 23:40 hrs on 18.11.2024.

Tamang (22 yrs), S/O- Sukumar Tamang of Halimchawk, W/No- 19, PS- Sadar Kishanganj, Dist- Kishanganj, Bihar (not verified) are desperate and dangerous in nature, as they were carrying the said fire arms for sell purpose.

As they have willfully violated the regulation of Arms Act, So, I pray before you for starting a case against the arrested accused persons namely [1] Sonam Tashi Tamang (25 yrs), S/O- Ashok Kr. Tamang of Below Ashangthang, Ward Salghari, PO+PS- Jorhung, Dist- Namchi, Suth Sikkim (not verified), [2] Harsh Kr. Tamang (22 yrs), S/O- Sukumar Tamang of Halimchawk, W/No- 19, PS- Sadar Kishanganj, Dist- Kishanganj, Bihar (not verified) under appropriate section of law and arrange for its investigation.
