In producing herewith the accused person namely Smt. Maya Ghosh, aged 40 yrs, w/o- Late Amir Ghosh, resident of Hansquan TG, beside NH-31, PS- Bagdogra, Dist- Darjeeling (not verified) under custody along with following seized articles under proper seizure list:

1. One (01) loose bottle COSMOS FIFTY Deluxe Whisky 50° UP India Made liquor of 750 ml,

contains approx 400 ml @ Rs. 250/-, marked as Exhibit-A.

2. One (01) gallon containing approx five (05) ltrs 'Chullu', marked as Exhibit-B. 3. One (01) gallon containing approx five (05) ltrs 'Chullu', marked as Exhibit-C.

4. Four (04) bottles Himalayan Gold 60° UP India Made Liquor, each contains 600 ml @ Rs. 160/-, marked as Exhibit-D.

(Total 12.80 ltrs)

I, SI Debabrata Kundu of Bagdogra PS, S.P.C, Dist- Darjeeling, do hereby lodge this written complaint against the arrested accused person namely Smt. Maya Ghosh, aged 40 yrs, w/o- Late Amir Ghosh, resident of Hansquan TG, beside NH-31, PS- Bagdogra, Dist- Darjeeling to the effect on 18.11, 24 that on 18.11.2024 at 14:45 hrs received reliable source information that a huge quantity of liquor is stored at the house cum shop of suspect Smt. Maya Ghosh at Hansquan TG, beside NH-31 under PS-Bagdogra and the same has been selling illegally. Accordingly, I informed the matter to O/C Bagdogra PS and as per direction I along with SI Samik Paul, ASI Amit Lama, C/1509 Sourav Roy Sarkar, VP/02 Pradip Roy & LCV/98 Shilpa Karmakar left for Hansquan TG, beside NH-31 to work out the secret source information. This refers to Bagdogra PS GDE No. 970 dated 18.11.2024. At around 15:05 hrs we reached at Hansquan TG, beside NH-31 and had been waiting for the source indication. After a while, the source indicated the house of the suspect Smt. Maya Ghosh and we proceeded to hold raid at the said house cum shop and managed to apprehend one person there and interrogated her. On interrogation, she revealed her identity as Smt. Maya Ghosh, aged 40 yrs, w/o- Late Amir Ghosh, resident of Hansquan TG, beside NH-31, PS- Bagdogra, Dist-Darjeeling (not verified) and she introduced herself as the owner of that house cum shop. We disclosed our identity to her and the input we had. We contacted with the local people to be present as witness during the process of search, seizure, if any. Two independent witnesses namely Pravin Kr. Minj (M/31 years), s/o- Peter Minj, resident of Shaldangi, Bhojnarayan T.E, PS- Bagdogra, Dist- Darjeeling and Miss Kusum Ghosh (F/20 years), d/o- Late Amir Ghosh, resident of Hansquan TG, beside NH-31, PS- Bagdogra, Dist- Darjeeling were present as witness. Then, we conducted search at the said house cum shop in presence of the independent witnesses and the Police personnel. On search, the above noted liquor was recovered from the said house cum shop. On demand, she failed to produce any valid document/license for stocking and selling that liquor. She further confessed that she has been stocking and selling liquor illegally from her house cum shop for a long time for her wrongful gain. Accordingly, I seized that liquor under proper seizure list and at last, arrested the accused Smt. Maya Ghosh (as noted above) with the help of LCV/98 Shilpa Karmakar after observing all legal formalities and telling her the ground of arrest to prevent the accused person from committing any further offence, to prevent her to cause disappearance of The process of search solving to the case and issued memo of arrest in this regard. The process of search, seizure & arrest was made in between 15:13 hrs and 15:45 hrs on 18.11.2024. The entire process of search, seizure & arrest is done through audio-video electronic means using mobile phone and then the same audio-video record is converted to a pen drive using computer system.

> Therefore, I request that a specific case under proper section of law may kindly be started against the arrested accused person namely Smt. Maya Ghosh, aged 40 yrs, w/o- Late Amir Ghosh, resident of Hansquan TG, beside NH-31, PS- Bagdogra, Dist- Darjeeling (not verified) and arrange for its investigation.
