Respected Sir, This is to inform you that some unknown persons entered my house last night and stole jewellery worth about 2 Lakh rupees (comprising of gold chain, gold bangles, 2 pair ear rings, 6 pcs finger ring, 1 wedding necklace) 1 Laptop, 1 T.V, ^{ACER} ^{INTEL} Cash Amount of Rs 43,000 and some other household items and clothes.

Sir, I am staying as a tenant in the residence of Mrs. h.D. Sherpa (resident of West Sikkim) at Ganesh Mandir Rd opposite Health Educational Institute. South Palas, Debidanga. I had gone to visit my brother at middle Palas around 8pm on 15-11-2024 as he was not keeping well and stayed overnight at his place.
