In producing herewith four (04) accused persons namely (i) Sangam Saibo (M-27 yrs) S/O Lt. Prem Saibo of Majhua, Debidanga, P.O. Champasari, P.S. Pradhan Nagar, Dist. Darjeeling (ii) Md. Buda (M-24 yrs) S/o Md. Hafijuddin of Ratanlal Busty, Mallaguri, W/No. 1, P.S. Pradhan Nagar, Dist. Darjeeling (iii) Utkarsh Sharma (M-21 yrs) S/o Basant Sharma of Middle Palash, Debidanga, P.O. Champasari, P.S. Pradhan Nagar, Dist. Darjeeling and (iv) Imran Hossain (M-28 yrs) S/o Lt. Endad Hossain of Anandamoyee Colony, P.O. Champasari, P.S. Pradhan Nagar, Dist. Darjeeling under arrest and the following articles under seizure viz (i) One iron made "Talwar" measuring approx 76' CM including pital butt. (ii) One iron made weapon locally called "Hasua" measuring approx 17" inches approx including iron made butt. (iii) One iron made "Hummer" measuring approx 15" inches approx, (iv) One iron made Sabol measuring approx 21" inches approx, (v) One Black and Blue colour Tourch light. and (vi) One purple colour bag. I, ASI Biplab Kr. Das of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted 04 (four) arrested accused persons and others 04/05 unknown miscreants who involve in this crime to the effect that on 22.11.2024 at 02.55 hrs I received a specific source information that about 09/10 miscreants equipped deadly weapons assembled at Regulated Market near Fish marker under PS- Pradhan Nagar, Dist.-Darjeeling and are taking preparation for committing Dacoity at Pokaijote and its surrounding areas.

Accordingly, I informed the matter to you and diarized the fact in General diary vide Pradhan Nagar PS GDE No 1178 dated 22.11.24 and as per your kind order and direction myself along with ASI Prabal Sarkar, C/1413 Sujit Sarkar, C/1119 Tamnoy Roy and C/1416 Dilip Barman all of Pradhan Nagar PS left for Regulated Market under Pradhan Nagar PS, Dist.-Darjeeling by Govt. vehicle with investigation kits to verify the veracity of the information without any search warrant or authorization for search which could not be possible to obtain from a competent authority for sudden development of a sensitive information and not to afford them opportunity for concealment of evidence or facility for their escape. I also informed one videographer namely Somnath Chatterjee, S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No 22, PS- Siliguri, Dist.- Darjeeling over mobile phone and requested him to come to Regulated Market with his camera for the purpose of videography if required. On the way, I briefed all the Police personnel sharing the information in hand and also informed RT van officer ASI Uttam Barman along with force C/880 Shyamal Dutta and C/830 Pradip Roy of Pradhan Nagar PS and requested him to come to Regulated Market to accompany with us. At around 03.10 hrs we arrived at Regulated Market and after a while RT Van Officer ASI Uttam Barman and his force came to Regulated Market and accompany with us. I briefed him and his team properly sharing the information in hand. And same time the above mention videographer called me over mobile phone that he came at Regulated Market. I requested him to come to Fish Market near Shanti Store. Then, I contacted with my source and from a considerable distance he pointed the place where the miscreants were assembled. Then, I requested two independent witnesses namely (i) Pramod Kumar (M-25) S/o Gopal Mahato of New Pokaijote, P.O. Champasari, P.S Pradhan Nagar, Dist. Darjeeling and (ii) Shyam Sundar Sah (M-50) S/o Lt. Ram Deb Sah of Pokaijote, P.O. Champasari, P.S. Pradhan Nagar, Dist. Darjeeling and I shared the information with them and requested them to remain present and act as witness if any search and seizure would be made, upon which they agreed.

Thereafter, we proceeded towards one store and cordoned the place with due care and cautioned and from a considerable distance we noticed that some persons were assembled inside the said store and they were whispering in a low voice. On seeing police personnel approaching towards them they tried to flee away from the broken wall of the market but on hot chase we managed to apprehended above noted 04 (four) accused persons while 04/05 others unknown miscreants managed to fled away from the broken wall of the said spot. Thereafter, we disclosed our identities as Police personnel (as we were in civil dress for our convenience). On interrogation, they disclosed their identities as noted above. On search recovered the above noted weapon of offence from their joint possession.

On further interrogation, they furnished incoherent statements and failed to give any satisfactory reply for their presence with deadly weapons in such deaf hour of night. Finally they disclosed that they along with 04/05 of their associates assembled there and were making preparation for committing Dacoity at Pokaijote and its surrounding areas. Accordingly, I seized the above mentioned weapons of offence from their joint possessions under proper seizure list in between 03.25 hrs to 04.05 hrs on 22.11.24 in presence of independent witnesses and duly signed by the witnesses and acknowledged by the accused persons and subsequently arrested them under proper memo of arrest and observing all the formalities of arrest. They are informed over the ground of arrest. The whole process of search and seizure were made under the coverage of video graph by the videographer namely Somnath Chatterjee, S/o Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No. 22, PS- Siliguri, Dist.- Darjeeling as per norms of BNSS and brought all the four (04) arrested accused persons along with seized articles to Pradhan Nagar Police Station for further investigation. From the above noted facts and seizure of incriminating articles there is strong reason to believe that all the above noted four (04) accused persons along with others who fled away gathered there equipped with deadly weapons at such dead hour of night and taking preparation to commit Dacoity in a nearby affluent area at Pokaijote and its surrounding areas.

Under the above circumstances, I pray before you that a specific case under proper section of law against may kindly be started against the above noted five (05) arrested accused persons namely (i) Sangam Saibo (M-27 yrs) S/O Lt. Prem Saibo of Majhua, Debidanga, P.O. Champasari, P.S. Pradhan Nagar, Dist. Darjeeling (ii) Md. Buda (M-24 yrs) S/o Md. Hafijuddin of Ratanlal Busty, Mallaguri, W/No. 1, P.S. Pradhan Nagar, Dist. Darjeeling (iii) Utkarsh Sharma (M-21 yrs) S/o Basant Sharma of Middle Palash, Debidanga, P.O. Champasari, P.S. Pradhan Nagar, Dist. Darjeeling and (iv) Imran Hossain (M-28 yrs) S/o Lt. Endad Hossain of Anandamoyee Colony, P.O. Champasari, P.S. Pradhan Nagar, Dist. Darjeeling and others 04/05 unknown miscreants and arrange for its investigation.
