With due respect, I, Nitu Basfore, D/O Late Arvind Mallick, resident of Barrack Quarter (RW), PO.-Sushrut Nagar, PS.- Matigara, District Darjeeling, West Benga - 734012 would like to lodge this complaint to your good office that my neighbours namely 1. Ranju Mallick, W/C Sanjay Mallick, 2. Kajal Mallick, D/O Sanjay Mallick, 3. Sanjay Mallick himself, 4. Mahesh Mallick, 5. Manju Mallick, W/O Mahesh Mallick, 6. Akash Mallick, S/O Mahesh Mallick, 7. Shiva Mallick, 8. Seema Mallick, w/o Siva Mallick always used to torture me and my family members, sometimes they throw stones on the roof of my teen shed house in night.

They have some pigs, who comes and spoils many things from my kitchen and temple and whenever they above mentioned people see me and my family members they started using abusive languages against us.

On 16.11.2024 and 17.11.2024, the above mentioned people came at my house and tried to threaten me and my family members. Sanjay Mallick and Mahesh Mallick state that "Hum tumhare ghar me ghush kr tumhara ijat lekar tumhe pure mohley main badnaam k denge or mohlay se nikalwa denge".

On 19.11.2024 the above mentioned 8 persons came with many more people (unknown people) at my residence mentioned above, where my one daughter namely nisha basfore was

present. They threatened my daughter Nisha and broke my house. As I was not there <sup>NB</sup> then they all came at my another house situated at thiknikata bazar, near Kali Mandir and Amit Agarv Bhawan, in medical, where I reside in rent and they found me there and then the above mentioned 8 persons beat me very badly until I started bleeding from my nose and forehead with the intention to kill me and then they stated that I do black magic, so they are beating me. Then somehow I manage to reach in nearest govt. Hospital with my son.

So, I request you Sir to be kind enough to arrange to investigate into the matter and take suitable action to book the culprits and to punish them as per law.


