Dear Sir,

With due respect I Shri Biswajit Das, WBCS (Exe), BDO Matigara Block, wish to lodge this written complaint against Sanjit Bala S/O Sahadeb Bala of Ghoklajote, P.S.- Matigra, Dist.- Darjeeling that as per Govt. norms we are awaring the public in general as well as shop keepers for not using the plastic carry bags under 20 micron through Miking, installing Flex, Festoons, Wall painting, Local T.V. Channels etc since long to protect natural environment. Use of such Plastic carry bags under 20 micron is very much dangerous for both public health as well as nature. Use of such Plastic carry bags are decreasing in a gradual way. However, some shopkeepers are still using such illegal Plastic Carry bags, violating Govt. Order, directions.

Today on 21/11/24 I got information that huge stock of plastic carry bags under 20 micron has been kept in a shop of Sanjit Bala S/O Sahadeb Bala of Ghoklajote, P.S.- Matigra, Dist.- Darjeeling

Accordingly a joint raid with the staff of BDO office and Police of Matigara P.S. has been held in the shop of said Sanjit Bala S/O Sahadeb Bala of Ghoklajote, P.S.- Matigra, Dist.- Darjeeling in between 18:53 Hrs to 19:03 Hrs on today i.e. 21/11/24 at Matigara Bazar. During raid a total of 105 Kgs of different sizes of plastic carry bags under 20 micron has been seized from the shop of Sanjit Bala S/O Sahadeb Bala of Ghoklajote, P.S.- Matigra, Dist.- Darjeeling by the Matigara P.S. During raid owner of that shop Sanjit Bala fled away.

Therefore, it is requested to take necessary legal action from your end, against seized plastic carry bags and the shop owner Shri Sanjit Bala S/O Sahadeb Bala of Ghoklajote, P.S.- Matigra, Dist.- Darjeeling and to arrange for it's investigation.
