I, Oyashin Ansari, S/O Lt. Taju Ansari, Aged about 55Years, Muslim by Religion, Daily labour by occupation, Indian by Nationality, residing at Paschim Dhan Tala, Binnaguri, P.O – Satellite Township, P.S – New Jalpaiguri, West Bengal, PIN – 734015, am filing this complaint with great concern regarding the suspicious disappearance of my daughter, Maherum Nessa, Age – 21 Years, Height – 5' 3", Female, Complexion – Dark, Build – Thin, Qualification – B.A 2nd Year of Surya Sen College, Religion – Muslim, Nationality – Indian, who has been missing since 26.09.2024.

We suspect that my daughter has been kidnapped or abducted by a boy named Saiyad Sonu, with whom she was previously in a love relationship. On the day of her disappearance, the above mentioned Saiyad Sonu made the last known call to my daughter, asking her to meet him and leave home permanently, which we came to know by a phone recording, which we got recently.

We further suspect that the boy's parents i.e., Boy's Father – Saiyad Munna and Boy's Mother – Mangli, may be involved in this matter and have assisted or facilitated her disappearance.

Despite our repeated attempts, we have been unable to contact my daughter, and this situation is extremely distressing, and we fear for her safety.
