chat since 15/11/2024 at around 11am and compelled me to give
Rs 5,48,000/- on 18/11/2024 at 1300 hrs. to them at the Bank account
as provided by the said miscreants. They introduce themselves
as Vinay Kr. Chauhan, Sub-inspector, Cyber Crime Mumbai and Later
to Akash Kulkarni, CBI/Officer. and started posing threat as
they were dealing a criminal case against me, saying Arrest
Warrant is with them and pressurised me to pay money immediately
to avoid arrest.

Out of unknown fear & social prestige, I was puzzled & transacted the
money from my Bank Account.

Now, I request you for necessary legal procedure in this matter against the
said miscreants and as well for recovery of my money of Rs. 5,48,000/- which I lost
due to threat of those criminals.
