That I am a MASON by profession.

That since few days few persons namely 1. SUMIT MALLICK, son of Sri. Dinesh Mallick, permanent resident of N.B.M.C. & H Group-D campus, quarter No. - A Block, Room No. 3, P.O. Sushrutanagar, P.S. Matigara, Dist. Darjeeling, 2. SURAJ MALLICK, son of Late Dinesh Mallick, permanent resident of N.B.M.C. & H Group-D campus, quarter No. - C Block, Room No. 4, P.O. Sushrutanagar, P.S. Matigara, Dist. Darjeeling, and his friends have been loitering in my above mentioned residential address in intoxicated condition and often creates ruckus in my area.
