I, the under-signed being resident of Milan Pally near electric
Office Siliguri, P.O. B.P.S. Siliguri, Dist. Darjeeling. Pin-734 was
do tender you this letter under the afore-captioned subject.

On 22nd Day of November, 2024 I after completion of my
work was returning to at my residence on my way at
Uttarayan Township exit gate at about 21:50 hrs at night.

As I was driving my car being KIA Seltos being no.
WB74BA4502 towards my residence at the afore-mentioned
Uttarayan Township Gate a man named Mr. Saroj Subha hit
my car with stone chip & after such hitting I had stopped
my car & encountered then him & to the reason of
his conduct.

He immediately further attacked me with a boulder stone
with an clear intent to brutally injure me physically
that would with all possibility have killed me immediately
immediately on the spot.

The evidence is a live-streaming video of the said boulder
stone visible in the video is clearly evident of such
dangerously grievously hurt & injury if hit physically.
In the said process of crime the afore-said accused has
broken & damaged my mobile phone by snatching & therefore
banging on the street.

I immediately called by police by dialing 100 & immediately
came for my rescue.
