On 22nd Day of November, 2024 I was after completion of my
work was returning to at my residence from my way at
Uttarayon Township exit gate at about 21:50 hrs at night.

As I was driving my car being KIA Seltos being no.
WB74BA4502 towards my residence at the afore-mentioned
Uttarayon Township Gate a man named Mr. Saroj Subha hit
my car with a stone chip & after such hitting I had stopped
my car & encountered that him & to the reason ~~why~~ of
his conduct.

He immediately further attacked me with a boulder stone
with an clear intent to brutally injure me physically
that would with all possibility have killed me immediately
immediately on the spot.

The evidence is a live-streaming video of the said boulder
