SUB: - Written Complaint against 1. Sri. Surojit Biswas, S/o Lt. Ganesh Biswas, and 2. Smt. Munmun Biswa, W/o Surojit Biswas, both are R/o Ashutosh Mukherjee Road, Subash Pally, Ward No: 19, within the jurisdiction of Siliguri Municipal Corporation, P.O. & P.S. Siliguri, Dist.: Darjeeling.

Sir,

With due respect I Smt. Shika Biswas, aged about 65 years, S/o Lt. Ganesh Biswas, R/o Ashutosh Mukherjee road, Subash pally, Ward No: 19, within the jurisdiction of Siliguri Municipal Corporation, P.O.& P.S. Siliguri, Dist.: Darjeeling, would like to draw your kind attention to the following effect that on 21.05.1994, my husband was died living behind me along with my 2 sons and 1 daughter they all were minor at that time my husband in his lifetime used to run a business of empty glass alcohol bottles, and at the time of my husband death he didn't leave any money for us to survive our livelihood, for which I being an unfortunate widow woman i was compelled to hold the business of my husband with the help of local people who were surrounded nearby i.e., Murgi Hati Bidhan Market, and I raised by kids on my own capability. That in the year of 2009 my aforesaid elder son married at his own choice with one Munmun Biswas, and from 2010 my aforesaid son started to physical and torture upon me due to want of money but I being a mother didn't lodge any complain against him due to public disgrace. Subsequently on 01.10.2022 at around 01:00 A.M to 1:30 A.M. my aforesaid son contacted my younger son through phone by saying that he will murder me at that time my younger son was in his friend's house on the eve of Durga Puja, hearing the same my younger son namely Subhrojit Biswas, rushed in my house then I narrated everything that the aforesaid elder son kicked me on my chest hearing the same my younger son entered the room of my aforesaid elder younger son and asked why he kicked his mother but without giving any reply the aforesaid elder son i.e., Surojit Biswas punched on the nose of my younger son for which perfuse blood was oozing from his nose and mouth. It may be noted that I have / had a business in the name of "Shika and Sons" and it dealt in hardware business of Iron, Road, Cement, Bricks etc and the said business was looked after my aforesaid elder son Surojit Biswas, taking the said advantage my aforesaid son took my signature on several stamp paper and other papers and I have / had also another business in my another shop room which dealt in home appliances and that business by my aforesaid elder son but my said son fraudulently without my consent and run the said shop under the name of "Soumajit Enterprise" and procured several papers fraudulently for his illegal gain and my said aforesaid son also availed huge loan from the United Bank amounting Rs. 25,00,000/- and again top up loan of Rs. 5,00,000/- by

misguiding me and those amounts were totally misappropriated by him, presently the United Bank is merged with Punjab Bank of India, my aforesaid elder son without this he also sub-merged several financial liabilities from several persons showing the business of "Shika and Sons", and those amounts was repaid by younger son to save me. It is pertinent to mention that my aforesaid elder son in all possible occasions used to mentally and physically torture me by involving in illegal activities such as he didn't pay the electric bill in my name however, he used the same, the WBSEDCL cut off the electric connection in my name but my aforesaid elder son hooked the electric connection from my shop having commercial metre to lighten his room. It is to be noted that it came to knowledge when the electric connection official came for local inspection on 13.11.2024 and found that the same and thereafter rang me about their presumption. It is bring to the knowledge that the electric connection which was installed in my name being Consumer Id No: 400448807 [Commercial] in my shop namely "Shika & Sons", but it is matter of regret to state that my said aforesaid elder on surrender the said commercial connection after forging my signature on a Non Judicial Stamp Paper after knowing the consequence thereafter the aforesaid elder son took a new commercial connection in his own name being Consumer Id No: 402999587 to grab my shop, recently my aforesaid elder son and his wife hatched up a deep rooted conspiracy to kill me by any means. It is pertinent to mention that on 18.11.2024 i.e., [yesterday] at about 11:30 A.M. my aforesaid elder son without my consent tried to demolish the partition of the said co-jointed two shop rooms to change the nature and character of the property structure and at that time I raised protest against such act of my elder son my elder son pushed me and mercilessly with an intention to kill me resulting in complete collapse and falling in the stiff of brick pile somehow the pedestrian rescued me from the said situation, however my elder son threaten me by saying that "ei baar bhache gheli, er porer baar tor jaan ami niye charbo sathe tor tor mey, jamai, chele, sob keh merea dibbo" thereafter I called one Preeti sarkar for my situation who took me at the Siliguri District Hospital wherein the attending doctor treated me.

The photocopy of the said medical copy is annexed with this complaint.

Therefore, you are requested to look into the matter and take proper legal action / steps against the above-named person and also provide me safety with regards to me and my younger son and recover the misappropriated money amounting Rs. 47,00,000/- and also to take all possible measures as per law.
