Dear Sir ,

With due respect and humble submission that I Arjun Paul , s/o Saylen Paul residing at South Bharat Nagar , Ward No 24 , Post : Siliguri , Dist Darjeeling would like to inform you that today i.e on 22.11.2024 at about 10.00 am in the morning my son Saybal Paul was travelling via NTS More more towards his college with Royal Enfield Classic vehicle Reg No. WB74BT9911 , At that time Mr Sandeep Chakraborty riding with Yamaha Ray-Z was driving recklessly on which my son protested him for rough driving . On the other hand the same the person name Sandeep Chakraborty was verbally abused him and used slaughter and slang languages. But my son was ignoring the fact as he had his Exam and chose to rush towards the exm centre. In spite leaving the area the person continously chased him down & caught him at the end of the FlyOver near Venus More. After getting hold of him he started hitting my son spontuinously with his helmate and with a brick nearby which resulted to a fracture in his nose and injured several other areas near by his head. Later the said person also attack him by some sharp object in the back shoulder. As a result it caused a deep cut with bleeding behind his shoulder. In this mishap the person snatched two Gold Rings attached with stones and I phone 13 Pro Max. Later my son manged to call me out for help . After few minutes I lost communication with him & sent out hurily to search him. I found him at Deshbandhu Para near BSNL office in a very severe manner my son was laid down in the road and the person was threatning to murder him. When I tried to rescue my son the person injured me on my face. Somehow I could manged to take the phone from him & recue my son from the culprit. As soon as I along with my injured son went to Siliguri Sadar Hospiotal & admise me to admitted my son in Siliguri Hospital then he was shifted to Neotia Hospital for the treatment. This was informed to me by my son (Saybal Paul)

So I therefore request you to lodge a FIR against the antisocial person and take an appropriate action against culprit.
