Siliguri, District - Darjeeling, would like to inform you that today my husband namely, Sadhan Saha and my son-in-law namely, Soundeeep Chakraborty went to Siliguri Police Station for lodging one F.I.R. for chain snatching matter which had been happened today. That at the time of returning from the Siliguri Police Station, one person namely, Babin Paul, son of Bappa Paul, resident of South Bhamat Nagar, Ward no. 24 of S.M.C. Dist - Darjeeling rode his motor cycle very rashly and he suddenly hit my son-in-law's scooter and for that reason my husband got cut injury on his foot.
