I, Khusbu Sha, holding the position of Human Resource Manager at Siliguri Greater Lions Eye Hospital, wish to formally lodge a complaint regarding an incident of forgery and misuse my signature and our hospital's stamp used for personal use.

It has come to our attention that Mr. Subir Kumar Paul, Son of Mr. Fatik Chandra Paul, permanent resident of Mohitnagar, Kharia(P), Mohitnagar Jalpaiguri, an Ex-employee of our organization, has unlawfully used the hospital's authorized signatory details and official stamp to apply for a loan. During the document verification this has been brought to our notice by the Axis bank verification team. This act was carried out without my consent or knowledge of the hospital's management.

This employee, Mr. Subir Kumar Paul, has not been associated with our organization since 26th November 2029. The misuse of the hospital's name, credentials, and seal constitutes a serious breach of trust and a violation of the law. This fraudulent act has caused reputational harm to our organization and created a potential financial
