Dear Sir,

Please be informed that **MR. TAPAN DEB SHARMA**, (PAN.CDGPS0140C), (AADHAR No.7917 4570 4837), Mob No.7583989619 residing at Adarsha Nagar Colony, Ward No.4, Near Govt. Sawmill Road, Siliguri 734005 was employed as a Store-In-Charge for last 7 years. He has stopped his duty suddenly in the office from 06.09.2024 onwards for the reason stated herein under.

The aforesaid Mr.Tapan Deb Sharma was given absolute charge of dealing with Tata Motors Passenger Car Products Division for entire West Bengal in our Company situated at **Diamond Plaza, 2.5 & 1.5 Mile, Sevoke Road, P.S. Bhakti Nagar, Siliguri 734001**. The said Tapan Deb Sharma sent Ledger Account of one of our party named M/s Jagadamba Enterprises for a period of 1st April'24 to Aug'24. The proprietor of the aforesaid Jagdamba Enterprises, M.G.Road, Jaigaon - 736182, Mr. Mahavir Agarwal on telecon with the undernamed Mr. Vijay Kumar Daga informed that certain goods amounting to Rs. 34,157/- against 4 invoices were never sent/delivered to him though they appear in the ledger. Mr. Mahavir Agarwal demanded for the invoice copy and consignment note for verification. On getting to know the above fact the under named Mr. Vijay Kumar Daga instructed the aforesaid employee Mr. Tapan Deb Sharma to provide the necessary documents to the party and a xerox copy of the same be forwarded to Kolkata Head Office. In the meanwhile the said Mr. Tapan Deb Sharma deposited the entire amount in the bank account of M/s. Jagadamba Enterprise and informed us that he has settled the account. Upon questioning Mr. Tapan Deb Sharma how he settled the account, he informed that he has deposited in Cash the entire claim amount in the bank account of Jagdamba Enterprises. We were aghested to know and enquired from where he got hold of the money, which he could not give satisfactory explanation. He there after stopped attending our office. We thereafter instructed our Branch-In-charge to verify and do stock checking and found several Tata Motor Original Parts are missing. A list of items missing valued approx Rs. 6 - 7 Lacs in annexed here to our Branch Manager called the said Tapan Deb Sharma several times in order to hear his version for missing items but there was no reply from his end.

We hereby request you to record F.I.R against Mr. Tapan Deb Sharma and take necessary action to help us to get our missing Automobile Spare Parts back.
