Respected Sir,

With due respect and humble submission I, Smt. Aakriti Jindal (Bhupal), W/o Mehul Jindal & D/o Sri Sunil Bhupal, now residing at Bhupal Building, Dr. kalinath Road , Khalpara , Silliguri , West Bengal – 734005, P.O. & P.S.- Silliguri, Dist- Darjeeling do here by submit under mentioned facts of complaint before you for taking immediate legal action against the abovementioned Accused persons as per law.

That I was working at ICICI Bank of Hyderabad Branch in the year 2022 and during April, 2022 I was introduced with Mehul Jindal who was then working at the same Branch and said Mehul induced me to marry him, , accordingly after a number of negotiations amongst our guardians, on 4th June, 2023 the 'Ring Ceremony' was held at Hotel Barsana situates at Silliguri, in the said ceremony according to the dowry demand of the Accused Persons my father was compelled to provide Rs. 15 Lakhs (fifteen lakhs) in cash as dowry in the hand of my husband Mehul, but they all were not satisfied with the said amount of money as they demanded more from my father. Finally my marriage with Mehul Jindal was solemnized on 28th November, 2023 according to Hindu rites and custom at Novotel Hotel, Shamsabad and afterwards our said marriage was registered on 16th December, 2023.

That at the time of marriage according to the demand of the Accused Persons my father was compelled to provide approximately 4 kgs of silver as ornaments, 250 gms of Gold in the form of ornaments and Cash amount of 60 lakhs as dowry articles to me and after marriage my husband Mehul took me to his house and I started to reside at my matrimonial house with my husband. On the first day of my matrimonial life with the instigation of other two accused persons my mother-in-law took my every 'Stridhan' properties in their custody forcefully.

That from the first day of my matrimonial life I have been teased by all my in-laws for the dowry articles and dowry money which were given by my father at the time of my marriage as those were unsatisfactory to the accused persons and they always compared stating that they have given so much more to their daughters and I have not brought their desirable quantity of articles from my paternal home.

In my matrimonial house I have been kept confined, moreover I was not permitted to talk with my paternal relatives over phone as per my wish, also I was not supposed to talk to anyone in the matrimonial house as well apart from my husband. Before marriage my husband assured me to allow me to work in their family business as I desire a job and compelled me to resign from my job, but after marriage with the instigation of other matrimonial relatives my husband told me to perform all the house-hold works and also told that this is my only job to do.

All the accused persons during my matrimonial life gradually started to tease me for not bringing dowry articles and money according to their expectation and slowly this teasing turns into demand of additional dowry money to be brought from my father and they on various time compelled me to relay their illegal demand for additional dowry money to my father, but as my father could not satisfy their demand, so all the Accused Persons continuously inflicted physical and mental cruelties upon me on about regularly.

All the accused Persons compelled me to do all the household chores. I was forced to stay in the kitchen and prepare food for all the Members in the house. I was not given food unless and until everyone had eaten and was supposed to clean the kitchen after that. I was not supposed to rest without the permission of my mother-in-law and my grand-mother-in-law. Even my husband used to yell at me because he was been guided by his parents. I was at my matrimonial house like a maid-servant as my father could not provided the additional dowry to the Accused Persons. In short interval my husband used to asked me to pressurized my father over telephone to provide them the additional dowry money, in such situation if I dare to raise any protest then my husband used to assault me and my mother-in-law inspite of saving me used to join with my husband, they both did such acts according to the instigation provided and being openly aided by my father-in-law, after such every assault I was not provided with minimum medication. My matrimonial family is a Joint family, besides parents-in-law and my husband there are other inmates who are also my in-laws, but during the infliction of torture upon me by the above mentioned accused persons those in-laws used to keep them-selves mum over the situation and never extended their hand to save me at any point of time.

That my father-in-law though is a blind person, but without his permission no one can do anything in the house, if at any time my husband began to assault me, then, my father-in-law used to command my husband and my mother-in-law to continue assault on me after locking the door of the room, so that none can hear my cry and always rebuked my husband by saying that my husband don't know how to keep frighten his wife and also ordered him to stay away from me and not talk to me. He was the main culprit for all the physical and mental torture experienced by me in my matrimonial house, he used to interfere in all the very private and personal matters between my-self and my husband and have also commented bad in public on our marriage in front of everyone to humiliate my parents and also my-self.

My paternal family was forced to send gifts and money as 'shagun' one every Occasion to my matrimonial house, on the Makar Sankranti (15th of January) and on Holl (25th March 2024) my father was compelled to send money and valuable gifts for each and every person of their house, the Accused Persons, forced me to convince and compel my Parents to provide all these things to the family of Accused Persons, at first I raised a little bit objection to convey those demand of the Accused Persons to my Father, but my husband with the instigation and command of his parents threatened me that if do not follow their command then I shall be kicked out from my matrimonial house and after hearing my such condition my parents followed the instruction of Accused persons for the safety of my life. That my husband on 11th April 2024 also came at Silliguri with me and stayed at my father's house for few days, where he on 12th April 2024 asked me to pressurized my father to hand over money as additional dowry, but as my father then was not in a position to pay the same, so I was assaulted at my father's house by my husband, my paternal relatives swallowed the incident for the sake of my happy future life in my matrimonial house.

On 30th April, 2024 My husband brutally assaulted me and bite me on my hand and abused me along with my paternal family members as I refused to create pressure on my father to provide the additional dowry to the accused Persons and after such assault I informed my situation to my parents, accordingly they were compelled to come at Hyderabad and made folded hand request to every accused not to inflict torture upon me, everything was settled but again after 10 days things started going south, Everyone in that family started threatening and abusing me including my husband. My father-in-law told my parents to take me away and also ordered me not live with my husband until their dowry demand is fulfilled.

The Accused Persons on various time compelled me to record my speech according to their directions, at first, I made some recordings on such compelling circumstances but afterwards I denied to do the same, so the level of torture was increased to it's paramount level.

That ultimately on 29th July 2024 evening all the accused persons pressurizes me to bring money from my father and as my father could not provide the same, so, I was brutally assaulted by my husband and my mother-in-law with the active aid and instigation of my father-in-law and my husband also tried to kill me by strangulating me and they asked me to leave their house and their torture upon me was continuing, I inform the matter to my father and accordingly he to save my life send my tickets and on 8th August 2024 I was compelled to leave my matrimonial house in a single cloth and took shelter at my father's house in injured condition and afterwards was treated by Doctor at Siliguri, till then I have been living at my father's house up till now, my all 'Stridhan' properties are lying in the illegal custody of the Accused Persons. The Accused Persons also threatened me not to come at their house without the dowry money as demanded by them.

That due to social shame and with the hope that the accused persons will come at Siliguri and will confess their guilt I have waited up till now, but ultimately the Accused Persons did not turned up, so some unavoidable delay has occurred in filling this complaint.

Under the above facts and circumstances I pray before you to take immediate strong legal steps to arrest the Accused Persons and take every measure so that they be punished according to law and also to recover my all 'Stridhan' articles from the illegal custody of the Accused Persons as early as possible.
